

#### **Dear Brothers and Sisters:**

Local 25 members have been hard at work these past few months working to elect proworker and labor-friendly candidates. It's not enough to just give our endorsement or hang a candidate's sign on our building. Members hit the phones and the streets to talk to working families about the importance of this election. And it worked. We were one of the very few unions to endorse Attorney General-elect Maura Healey in early summer, who handily won the primary and general elections and is a rising star of the Democratic Party. We were successful on the casino question, which will mean thousands of good jobs for this state. Even though our candidate for governor didn't win, she lost by less than a 2-percent margin with more than 2 million votes cast, proving that every vote really does count.

Our GOTV "Get Out (the) Teamster Vote" was phenomenal and I'd like to thank everyone for their hard work. This election season we utilized e-blasts, phone texts and social media to keep members informed throughout the election season. If you haven't done so already, sign up for Local 25 action alerts on our website to stay informed on important issues.

This issue we highlight a few of Local 25's young leaders. They are the future of this union and are boldly making their mark. The Futures Committee worked alongside the Retirees Chapter all summer and fall on the election and will only grow as they become more involved.

In addition to electing state leaders, our local has been busy. Our scholarship golf tournament raised \$60,000 for students and more than 140 stewards participated in our annual program. Eleven Local 25 sisters joined 1,000 sisters from across the country at the 14th annual IBT Women's Conference. I'm excited to announce that the 2015 convention will be in Boston next August. This will be a chance for us to showcase Local 25 and the strong stake we have in the community.

This year marks the 50th anniversary of our blood bank, which we hold eight times per year. Since 1964, we've collected thousands of pints of blood working with the Red Cross. If you've never donated blood, it's quick and easy and the life you save could be your own.

Joan Corey and Jason Lopes' roles have changed to Business Agents and they will replace outgoing officers Robert Fabrizio and George Slicis. Kyle Dexter has been appointed Field Representative. I look forward to working with them.

## Secretary-Treasurer Mark Harrington


Over the summer and fall I, along with the assistance of stewards Tom Mahoney, Jim Benedetto, Jim Ippolito and Dan Donohoe, completed negotiations with the following companies: O.B. Hill Flatbed Division, Aggregate Industries Paving Division, and Global Chelsea and Revere Plantmen. All agreements provided for wage increases, health and welfare and pension contributions to maintain the current benefits. I am happy to report all contracts were ratified unanimously.

It was also very busy at Manfi Leasing, where business was at an all-time high because of the Market Basket situation. The drivers did a great job servicing Stop

& Shop during this chaotic period. We were successful in arbitration returning two terminated drivers, one with full back pay and benefits. We have a pending arbitration case regarding hiring. I hope to be successful so we can add drivers to the list.

Once again, our Scholarship Golf Outing was a huge success. We had more than 144 golfers and we raised \$60,000. It couldn't be done without the help of Co-Chairman John Murphy, President Sean O'Brien, Trish DiSilva and the countless volunteers.

As I reported at our fall general membership meetings, our Local continues to operate in the black. We continue to be in strong financial position to take on the many fights that are in front of us!

We have ongoing negotiations with our police groups at the UMASS Boston and Lowell campuses. These negotiations are heating up and our goal is to attain parity with other UMASS police departments. We also continue to bargain with the City of Woburn Department Heads and our three groups in Everett. This city has suffered financial difficulties for the past few years but we hope conditions will improve.

The Trade Show Division has been busy since the end of summer with the Sibos show in September. We utilized every referral we had available for this show and our

members did a great job getting that show in on time. In fact, because of the great job members did, Sibos will return to Boston in 2020! In October, we added a D list to help our members get more work.

In the trash industry, we will ask the Boston City Council to sign a resolution that no company will be allowed to use temporary workers to supplement their workforce. This would mean every worker would need to be a bona fide employee of the employer. This would ensure every trash worker in Boston has the proper background check and gets compensated correctly.

At UPS, I now represent Norwood, South Boston, Somerville and East New England Feeder drivers. UPS has been extremely busy since last year's peak season and it doesn't seem like it will slow down anytime soon. This means long hours for our members which can be tough to deal with. I would remind all UPS drivers that they have rights under our contract, for excessive overtime you have the 9.5 rule. We continue to enforce this contract every day and if you are on the 9.5 list you will be paid the penalty if management does not correct your dispatch.

Thank you to all my stewards who make Local 25 the best local.



## Business Agent John Murphy

We recently completed Massport Worcester Airport negotiations and this contract will run concurrent with Logan Airport's contract. Chief Steward Spike O'Brien and I were able to increase wages over the three years by 15 percent, stabilize health

care and co-pay costs, get new uniforms for the Aviation Safety and Security Officers, and include language to provide maintenance facility renovations.

I'm also in contract negotiations with the Town of Winthrop and United/Continental Airlines mechanics. As of this writing, I am waiting for mediation dates for Air Canada and Gate Gourmet. I also have a new assignment, Mystic Island Transport.

In the Freight Division, YRC, as well as all companies, are now taking a hard line on discipline when it comes to violations of the CSA (Compliance, Safety and Accountability) program set forth by the Federal Motor Carrier Safety Administration (FMSCA). This is a program that assesses points to the motor carrier, as well as the driver, in seven categories: unsafe driving, hours of service, driver fitness, drug and alcohol, vehicle maintenance, hazardous materials and crash indicator. If a company and/or driver is assessed points that exceeds a certain score in any one of the seven categories, both can be fined and have a suspension and/or loss of license.

This local is involved in the IBT organizing that is now going nationwide with FedEx Freight. We will be asking all our brothers and sisters on the road to speak with the FedEx drivers in our bid to organize them.

Electronic tolling on the MassDOT Tobin Bridge is now fully operational. All of our members have either moved to the Mass Turnpike tolls or have taken the buyout.

Our Credit Union's goal is to meet all of your financial needs and we continue to add great new services. Our new and improved website offers easy navigation and online loan applications. Soon you'll be able to open an account online. We granted more loans through the first eight months this year than we did in all of 2013 and our 30-year fixed rate mortgage is at 4.125 percent with no points. We have partnered with Green Path Debt Solutions to offer members credit counseling if a member had past credit issues and is ready to get back on track. We have completed a first-time contract for the newly organized Medford DPW. The contract expires next year so we will be right back in negotiations shortly. We also completed negotiations with the Somerville Housing Police.

Both were strong contracts and were ratified unanimously. We continue negotiations with the City of Cambridge and are getting close to an agreement.

I have recently been assigned to represent the Liquor Division consisting of Charles Gilman & Sons (Martignetti Company) and MS Walker. I have met with the stewards, visited the members at both companies and had a Credit Union sign-up visit at both. I look forward to working with and representing the members in this Division.

Future Committee members Derek Briggs and Chris Smolinsky recently joined me on the job as part of Local 25's "Shadow a BA" program. Briggs attended negotiations for the City of Cambridge and Smolinsky attended an arbitration hearing for Independent Pipe & Supply. I enjoyed the opportunity and thank them both for their efforts and enthusiasm.

I also recently spent a day working as a Parking Control Officer in the City of Cambridge and a night unloading trucks at UPS Chelmsford. President O'Brien has mandated this initiative and we welcome the opportunity to work with our members in the trenches. I have several more days scheduled so I will see you in the workplace.

In the Moving & Storage Division, we have recently signed an agreement with the Carpenters Union resolving decades of dispute. This agreement will secure Teamsters work that has previously been done non-union and also clarify jurisdict ion for the work that was shared by both unions. We think that this agreement is great for both unions and will allow us to work together as one to organize and protect all of our work.

We are preparing for the Ace & Acme negotiations that will begin after the first of the year for a contract that expires on April 1. This is the only moving contract in Massachusetts that has no Teamsterscare benefits, no top pension or annuity and no group legal services. It also has inferior wages and no overtime after 8 p.m. We have nowhere to go but up! This company has indicated that it plans to take on Local 25. I accept their challenge and look forward to seeing them at the bargaining table.

At UPS, we have handed out the new contracts to all buildings and all shifts. Please see any steward if you did not

receive one. Read it, know it, and enforce it!

We are also preparing for what is again projected to be the biggest and busiest peak season ever at UPS. We will be meeting with the management in the next several weeks to discuss their plans and will report back to you anything important that is on the horizon. I have also attended all New England, Eastern Region, and National Panels for UPS and UPS Freight since my last report.

As always, use union movers, ship all packages UPS and organize the unorganized. Have a great fall season!



#### **Business Agent** Robert Aiguier, Jr.

It's been a busy summer and fall with both negotiations and organizing. The members at Golden Living nursing home ratified a contract that includes yearly wage increases, language improvements, a higher starting wage for dietary aids, and

improved the scheduling from every sixth weekend off to every other weekend off.

Negotiations with Emerald Green Building Services were also complete d this summer. This contract includes wage increases every six months and an additional paid day off. The hard working members of Emerald Green ratified the contract unanimously.

At VPNE Parking Solutions, 130 new members ratified their first union contract unanimously in August. With it they'll receive yearly wage increases, a pension, 11 paid holidays, six paid sick days, two paid personal days, jo b security, a grievance procedure, and many other benefits.

Organizing in the Parking Industry is ongoing. We recently secured a card check neutrality agreement for the first group of LAZ Parking workers. Outside of parking, 17 security supervisors at the Convention Center voted to join Local 25 as well. Welcome to the family!

In August, I spent the day working as a valet with the new ProPark members at the Battery Wharf Hotel. I must need to work on my customer service skills, because I only received one tip my entire eight hour shift! When parking in and around Boston, try to remember our new brothers and sisters in the parking industry. Let them know you're a member of Local 25, and remember to tip your valet! Current Local 25 parking companies are VPNE Parking Solutions, ProPark, ImPark, Central Parking and Standard parking.

President O'Brien recently assigned me a number of new

groups. I've reached out to all the stewards and look forward to working with them. Best wishes to all members for a happy fall and holiday season.



#### **Business Agent** Joan C. Corey

I'd like to first thank President O'Brien for his trust in appointing me Business Agent. I understand that I am the first female to ever hold this position in the history of Local 25. It's decisions like this, by our progressive and forward-think-

ing president, that promote diversity and equality and will sustain the future of this great local.

We are currently in negotiations with the city of Woburn Department Heads, city of Everett Clerical and 911 workers, and workers from the town of Acton and town of Brookline. I have begun proposal meetings at Cambridge Health Alliance/Whidden Hospital. These members are respiratory therapists and surgical technicians.

The biggest challenge we face in the public sector is health insurance. Several years ago, there was state legislation that passed which altered bargaining rights of health insurance for public employees statewide. As a result, there have been significant changes creating inferior coverage combined with significant cost increases. We will take these battles on one community at a time. I remain very confident that if members stand together and stand strong we will succeed in maintaining good healthcare coverage which all our members and their families deserve.

This September I was honored to join 10 Local 25 women and attend the Teamsters Women Conference in Chicago. We were inspired by women leaders from across the U.S. and Canada. Next August the Teamsters Women's Conference is coming to Boston. This will be a tremendous opportunity for all our Teamster brothers and sisters to showcase Local 25, Joint Council 10 and our Preside nt Sean O'Brien. Planning has already begun.

In closing, I will be forever grateful for the opportunity to be an advocate on labor issues. Thank you to all who inspire me, encourage me, and support me in this endeavor!

# LOCAL 25'S YOUNG GUNS

Futures Committee Forges Path for Future Generations

ast March, President Sean O'Brien had an idea to attract young members' participation.

"We were at a crossroads with our younger members. They attended monthly meetings but that was it. There was nothing connecting them with the history of this union," O'Brien said. "So I challenged a few of the younger members to start their own group, and the response has been phenomenal. More than 40 members attended the first meeting and they have been active ever since. They are the future of Local 25."

We sat down with three young leaders to learn more about the Futures Committee.



Kyle Dexter is Chairman of the Futures Committee and a Local 25 Field Representative. He worked in the moving and storage division at Metropolitan and was the facilities manager at TeamstersCare.



Christopher Smolinsky is Vice Chairman of Futures Committee. He works in Trade Shows/Moving and Storage.



**Jason Lopes** is a Local 25 Business Agent and liason to the Committee. He worked for 11 years at Stop & Shop warehouses.

## Q: What are your goals for the Futures Committee?

*Kyle Dexter:* We want to engage younger members and motivate them to be an active part of the union. We need to educate younger members on how the union can help them. We've already collaborated with the Greater Boston Labor Council's Futures Committee and will continue to do so on common goals.

**Christopher Smolinsky:** We need to begin to develop the next generation of Teamsters. We would also like to start a charity so we can help people in need.

Jason Lopes: To move the labor movement forward we need to educate younger Teamsters on our rich history. The face of the Teamster is changing, and first generation Teamsters don't have the luxury of having the knowledge of previous generations passed down at the dinner table.

## Q: Why did you get involved with Futures?

**CS:** At a membership meeting, President O'Brien said that less than 1 percent of Teamsters actually participate in union activities and on my ride home that day I told myself I wasn't going to be part of that 99 percent. I did some research and found out some union activities that were coming up, and that was my beginning.

# Q: How do you think the committee will be able to make the most impact with members and the union as a whole?

**KD:** Having a dedicated committee for those under 35 creates an instant

connection for these members. We share the same issues and can learn from one another.

**CS:** I think I'd be selling the Futures short if I tried to guess where we'll have the most impact. The sky is the limit when you put a bunch of young Teamsters together with the guidance from the great leadership of Local 25.

JL: Futures will be successful as long as they are seen. They need to participate as a group at volunteer and political events and form their own identity. They are already being noticed and getting positive attention; now they need to build off of this initial momentum. With the full support of the local and President O'Brien, great things will come from this group.

## Q: What has initial feedback from members been?

**JL:** I have heard nothing but positive feedback from the members, both young and old, as evidenced by the Retirees Chapter joining forces with the Futures to attend public events. The Futures have been instrumental in the GOTV and DRIVE campaigns.

## O: What have you learned from other members in Local 25?

**KD:** Leadership is very supportive and helps us in every way. It's the complete opposite of the traditional thoughts of workplace separation with older and younger members. Hearing the retirees "war" stories helps us understand the history of the union while watching their involvement in literally everything shows us what it means to be part of something special.



## Local 25 Gets the Vote Out


#### Members Help Elect Strong Women Leaders, Keep Casinos in Massachusetts ———

ocal 25 members knocked on hundreds of doors, made hundreds of phone calls and rallied throughout the primary and general election for our endorsed candidates. Local 25 members were represented at every major political event this year. The hard work paid off: Local 25 helped to elect Maura Healey Attorney General, Deb Goldberg State Treasurer, Seth Moulton U.S. Representative, as well as a host of other candidates in contested county and legislative races. Local 25 was successful in the "vote no on 3" casino/jobs bill that will create

10,000 permanent jobs, 6,500 construction jobs and \$400 million in new revenue for cities and towns across the state.

"From the Democratic State Convention to election day, Local 25 had a large presence. "Our Women's Committee has already started meeting to talk about the conference, brainstorm ideas and talk about how best to showcase the city of Boston, and the strong women that are members of our union."

Next year's conference will be held at the Westin Hotel in the Seaport District in August.

"Supporting our endorsed candidates is very important, as we want to make sure people with the same interests as us get into office," Dexter said. "Speaking to the candidates and their campaign team, you really find out how appreciative they are of all the support the union gives, and we were glad to be a part of it."

In July, we joined in a week-long parking organizing campaign to bring dignity and respect to over 500 parking workers. Local 25's parking industry is one of the fastest growing industries in our union.

We have also been helping Operation Exit, an initiative of Boston Mayor Marty Walsh that places "at risk" teens into apprenticeship programs in the trade unions. Chris Smolinsky has been helping with the program by providing transportation to the different sites. This is an opportunity to introduce young adults to the trades and show them that they can make a decent living in these fields and how a union can help.

We believe that as the future of this union, it is our job to recruit new members. In the near future we will implement a new member orientation program, led by Derek Briggs. ## **Organizing for POWER**

#### **Local 25 Stewards Attend Annual Seminar**

ore than 140 Local 25 stewards and officers attended a one-day seminar on October 25. With the state elections taking place less than 10 days after the seminar, the theme was organizing—for our endorsed candidates, on Beacon Hill, in the workplace and within our union.

"The stewards play an invaluable role in this union," President Sean O'Brien said. "They are our foot soldiers on the ground, keeping our members informed day to day. The annual stewards' seminar is a way for them to learn about key initiatives of this union but also interact with their peers."

The program kicked off with a "War on Workers" segment that highlighted the importance of supporting DRIVE, our legislative initiatives and political clout attained in recent years because of political victories. Local 25 recently wrapped up one of our and the International Union's most successful DRIVE campaigns ever.

Stressing that "all politics is local," Joe Giannino, Government Relations Group, LLC and Local 25's lobbyist, told attendees









that the best thing they can do to help our priorities is to meet their legislators.

"It's your job to meet your legislators, make sure they know the things that are important to us and that they also know that we're paying attention, that we know who they are, and we know how they vote because we vote too," Giannino said.

Tom Vitiello, Alternate Steward at UPS Somerville and a 17-year member of Local 25, spoke to stewards about substance abuse in the workplace, the tell-tale signs and what you can do about it. "Substance abuse continues to be an issue that workers across all industries struggle with and Local 25 members are no different," said Tom Morrisey, Safway Scaffolding. "The presentation was timely and walked us through what to do if a member is battling substance abuse and what types of resources are available to them and their family."

Other presentations included an overview of the Futures Committee, a group for members under 35 years old; and an overview of the nuts and bolts of

organizing in your workplace and the union. Jim Donovan, Local 25 political coordinator, briefed attendees on our ongoing communication initiative that includes text and email alerts, and conference calls.



This was my first time in this office as I was picking up a prescription for a neighbor he always said it was a great place and now I believe him.





# 50 Years of Giving Life



Petiree Lou Mailett was at Local 25's first blood bank in 1964 and he's spent the last 50 years volunteering for each drive.

"In the early days we'd have 20 beds with people lined up out the door and around the corner waiting to donate," said Mailett, a 40-year truck driver with Wooster Express and North Penn Transfer who joined the union in 1950. "We have a lot of laughs each month but it's the blood donors that keep me coming back to help. I've seen how the blood bank has helped people and that's the goal."

The blood bank is held eight times per year on the fourth Saturday of the month. There is no blood bank during the summer and December. Donors are able to give blood every six weeks. The American Red Cross Massachusetts Blood Services Region works with Local 25 to execute the program.

"The Red Cross truly appreciates Teamsters Local 25 for being a committed blood drive sponsor for more than 50 years. Your efforts have helped hospital patients and their loved ones make more memories," said Jeff Meyer, CEO, Massachusetts and Connecticut Blood Services Regions. "Volunteer blood donors are needed every day to help keep the nation's blood supply at adequate levels."

#### **A Community**

Mary Ellen Kelleher, a Red Cross volunteer, was initially assigned to Local 25 five years ago and has since turned it into her permanent assignment.

"From day one, I was so impressed with Local 25 and what they do in the community that I knew this was something I wanted to be part of. It's an amazing group of people that feels like family," Kelleher said.

Local 25 Secretary-Treasurer Mark Harrington, who is also Chairman of the Blood Bank, praised the committee.

"The majority of the committee members have been volunteering their time for the blood bank for more than 20 years," Harrington said. "Donors return month after month because we run an efficient operation and it's all because of the committee. Retiree Bill Gontarz drives down from Holden, Maine, each month to volunteer his time!"

"We have a great bunch of volunteers," said Local 25 Retiree Chapter President Joe Conti, who oversees the logistics. "They show up at 6 a.m. and work straight through till 3 p.m., never complaining and always with a smile."

#### 'A Lifesaver'

Paul Lacey, who works at YRC Freight, said he gives blood a couple times a year and that many of his colleagues do as well.

"It's an hour out of your day but could be a lifesaver for someone in need of blood," said Lacey, who was the clock winner at the Oct. 25 Blood Bank.

Through the years special blood banks have been held to assist Teamsters families and those in the community.

"After a house fire in Charlestown many years ago left a family severely burned, we gave the family 110 pints," Harrington said. "After the Boston Marathon attacks, there was an outpouring of donors and we extended hours to accommodate donors."

Charlestown resident Julia Devine originally gave blood to get over her fear of needles two years ago. She now considers it her "civic duty and gives every two months."


Mailett has no plans to retire from the committee any time soon. "Come back in another 50 years and I hope to still be here," he said with a grin.

Greetings from the Executive Board to all our retirees. We hope you had a nice summer and fall. The weather was great for all events.


