#### **Dear Brothers and Sisters:**

It was a long, hot summer for the members of ABC Supply Company. Our members voted to strike on May 7 and we were still on the picket line on Labor Day. They stood strong and after 125 days on strike, on September 8, they ratified a five-year contract that includes increased wages, a signing bonus and several benefit improvements. I'd like to thank all of the agents who helped to keep the picket lines at the four facilities staffed 24-hours a day and the membership for your support. This wasn't just a strike about ABC Supply Company, it was about the entire labor movement. In our victory, we sent a message to corporate America that the labor movement, and Teamsters Local 25 in particular, won't be bullied. We may not have the financial resources of corporate America, but our Union has heart and intestinal fortitude. Corporate greed never wins against courage and conviction.

The labor movement continues to be under attack. By the time you read this, we'll have a new president-elect. I hope you got involved in this year's election and voted. Although the election is over, we all need to remain vigilant and make sure our elected officials follow through on the promises they made to fight for working families. Keep this in mind during the all-important midterm elections in 2018.

Local 25 continues to see growth. Recently, members at Teamsters Local 259 voted to merge with us, and 80 members from the City of Waltham voted to join Local 25. I'm looking forward to working with our new members who work in the newspaper industry and municipal government.

On September 10, we held our annual golf tournament. More than \$71,000 was raised for our scholarship fund that directly supports children and grandchildren of our members. Thank you to all who supported this cause.

On October 27, the executive board voted unanimously to appoint Andrew Walsh as Business Agent, followed by the November 3 appointment of Peter Berry as Recording Secretary. I am looking forward to working with both in their new roles.

It was 10 years ago on August 11 that I became President of this great local. I made a pledge then that I still carry with me today. I would never ask you to do something I wouldn't do, and that I would always work to the best of my ability for our members. We've had our challenges and successes, but through it all we've stood strong together. We, the 11,500 members of Teamsters Local 25, are a force to be reckoned with. Our mission and commitment will never waver. We continue to fight corporate America with vigilance, as corporations look to outsource our jobs, and try to cut our benefits. The new year will bring more negotiations, and attacks to pensions and health and welfare benefits. You can be sure that we'll be at the table fully equipped with the knowledge but more importantly the support of our members as we continue to fight.



# Officers' Reports

In August we had reached a tentative agreement in negotiations with Jack Cooper (National Automobile Agreement). Since then, the ballots have been mailed out and counted. Unfortunately, the national agreement was voted down, 1,811 no to 1,479 yes. The Eastern Region

Supplement was voted in and our members voted 37 to 0 in favor of the entire agreement. We are waiting for the national negotiating committee to advise us on what is the next move.

In the Oil Division, we will be having our pre-winter meeting in November here at the union hall. We completed contract negotiations and ratified a contract at Sunoco Logistics. We continue contract negotiations with the dispatchers at Global.

The Trade Shows Division continues to be busy and we are planning a meeting for referral members to discuss the system prior to negotiations. We will start negotiations this coming spring.

At UPS, I attended the National UPS panel in Indianapolis in September where I presented the panel case over the  $3^{\rm rd}$  Doctor Rule under Article 20. This case was deadlocked and will now go to arbitration.

As the Secretary-Treasurer of this great local I am pleased to report that we continue to run Local 25 responsibly fiscally and we are constantly looking for ways to conserve the membership's money. Nothing is off the table when it comes to making sure this is the most powerful and financially sound local in the country. Your leadership team, under the direction of President O'Brien, is committed to being number one.

Lastly, I would like to thank the entire membership for your continued support of the Sean O'Brien leadership team and I look forward to working tirelessly for you in the future.

## Vice President Steve South

We have completed contracts with all seven companies in We have completed the contract for Charles Gilman and Sons (Martignettis) after several months of negotiations. The company is consolidating with United Liquors in a new facility

in Taunton that will have three Teamster locals (25, 122, 653) under one roof. The new contract includes yearly wage increases, protection of pension and health and welfare, expansion of work jurisdiction and many other improvements. The contract was ratified 24-2 on September 10. We also completed the contract for the newly organized City of Cambridge ECC supervisors, which was ratified unanimously on September 19. Their first Teamster contract provides them with yearly wage increases, Teamsters Dental/Vision, Group Legal Services, new stipends and job security.

Negotiations are ongoing with the newly organized Boston Pipe and Supply as well as Watertown DPW. We have also begun negotiations with the City of Medford school security monitors who were organized at the beginning of the summer.

We collected authorization cards from the City of Waltham DPW employees over the summer. The workers had been members of an independent association. On September 27, the employees voted overwhelmingly to join Teamsters Local 25. I look forward to representing our 82 new members there and securing them a strong contract as their current contract expired in July.

In the Moving and Storage Division, we continue to fight Ace and Acme at the National Labor Relations Board over their false closure and subsequent reopening with nonunion employees. We will pursue this greedy company in every arena to get our members what was negotiated at the bargaining table.

At the UPS Chelmsford facility, we have secured the largest grievance settlement involving supervisors doing our members' work in the history of New England, paying our members in the UPS Hub 1,200 hours at double-time. Thank you to our stewards and members who are diligent in enforcing the contract every day to hold the company accountable. On September 22, UPS successfully tested a drone delivery to an island off the coast of Massachusetts. This is a major development and a reminder of how fast technology is progressing and our responsibility to address these and many other important issues in the years to come. I would like to thank retiring UPS Logan steward Sam Toste for his many years of service and welcome Maria Martinez who is the new steward for the morning shift.

As always, make sure to use UPS when shipping your packages this holiday season and use union movers.



# Business Agent John Murphy

Our members at the Massachusetts Port Authority at Logan have ratified a new three-year contract at 3 percent a year, maintaining the health and welfare costs, as well as sick leave and its usage under state laws. The Town of Boxford Police

Department contract has been ratified with a wage increase of 4.5 percent over three years, which includes an increase in the wage rate the town pays and the outside-details rate, and increases in the educational incentive.

Negotiations with North Reading DPW, which I thought we wrapped up in April, has hit a snag. We will have to file for arbitration because the town will not authorize the back wages. As of this writing, negotiations are still ongoing with Worcester Airport and the Boston Globe.

We have also ratified three-year contracts at the following companies: Beacon Sales with 2-percent wage increases, maintaining Teamster Dental and Eye as well as Teamster Pension; Ryerson Steel with 50-cent, 55-cent, and 65-cent-per-hour increases, as well as maintaining Teamsters pension and Teamster Dental and Eye; and Lindenmeyr Munroe wage increases of 50 cents each year, five sick days and maintaining the Teamsters Health/Welfare and Pension. NONE of these contracts would have been possible without the courage of our members from ABC Supply Company.

After 125 days on strike with the biggest anti-union company we have ever dealt with, the 20 courageous men who work for ABC Supply Company ratified their contract September 8. The contract is a five-year deal with increases of \$3 in wages over the life of the contract, a \$5,500 signing bonus, five sick days every year starting January 1, as well as maintaining overtime after eight hours, \$2.15 an hour in our Teamster Local 25 Savings and Investment Plan in the first three years, an annuity run by Teamsters, and \$2.25 an hour the last two years. Also included is better layoff and recall language, and increases to the new hire rates. In total, our members will receive \$11,396 more per year, not including overtime.

I would like to thank all the officers and agents who stood tall with our members on the line at our four locations, the members who came by every morning, every afternoon and every night to walk the line, lend support, bring food and drink, and donate a grand total of \$11,097 in cash. You are the best members in the labor movement.

To President and Principal Officer Sean O'Brien, this local union spent \$113,459.56 to beat back the BULLY! We would not have been able to win this strike without you. Thank you for your leadership, your support and your advice throughout this campaign. You negotiated the final package

and it's proof that Local 25 really is the best union with the best leadership and members.

We held our annual scholarship golf tournament on September 10. On behalf of President O'Brien, I would like to thank all the staff and members who volunteered and/or played. We raised more than \$71,000 that will directly help member's children with their college education.

# **Business Agent Robert Aiguier, Jr.**

I hope everybody enjoyed their summer and got in some quality time with their families.

Currently, we're in negotiations with three companies in the Parking Industry: SPplus, ProPark and ImPark. It's hard to believe we're

already in our second round of contracts in the Parking Division. The division continues to grow with the addition of three more VPNE parking locations and a new unit at SPplus that was formerly nonunion.

Since my last Construction Division report, the Wynn Casino Project has started up and is well under way. We currently have members operating end dumps and water trucks, as well as placing and servicing the dumpsters and porta-potties. Both Boston Sand and Gravel and Aggregate are supplying the concrete. Construction in the Boston area continues to be strong with new projects starting up regularly. We're out there policing sites to protect jobs for Local 25 members.

At Safway Scaffolding, with the help of steward Tom Morrissey, we were successful in returning a terminated member to work. He was out of work for three weeks. His termination was reduced to a suspension with back pay.

We also recently won the sick-day arbitration with Boston Sand and Gravel. The company will be providing employees with paid sick time moving forward.

When parking in and around Boston, please remember our brothers and sisters in the parking industry. Let them know you're a member of Local 25, and remember to tip your valets! Current Local 25 parking companies are VPNE Parking Solutions, ProPark, ImPark, SPplus and LAZ Parking. A map of Teamster parking facilities can be found on our website. Please continue to boycott all Pilgrim Parking locations until they agree to give their workers a voice in the workplace.

In closing, I'd like to congratulate the members at ABC Supply Company, and those who came out in support, for holding strong on strike for 125 days. When we stick together, nobody can stop us.



# **Business Agent Jason Lopes**

I hope everyone enjoyed their summer, it's hard to believe that it's already time to start prepping for the holiday season. I'd like to start off my report by congratulating our members at ABC Supply on their hard-fought victory. Walking the

picket line with you for 125 days was not only an honor but a privilege. You remained strong and united and showed this company and the rest of corporate America that the labor movement is strong. I'd also like to thank all of the members, especially the Teamster Horsemen, for their support of these courageous Teamsters over the course of the summer.

We are currently in negotiations with the American Red Cross for the newly organized biomedical technicians. Under the national contract they will be enjoying yearly raises, a comprehensive union health insurance plan and job protections. We should have the local agreement wrapped up by the time you read this report. An agreement was also reached with the Red Cross for a base wage increase for our drivers who have CDL licenses to operate the buses. They will be receiving a \$1.25/hour increase and those drivers who are required to drive DOT vehicles will receive a 25-cent base wage increase.

We have begun negotiations with Certainteed Roofing, and I look forward to bringing our hardworking members a strong contract that protects their top of the industry health insurance, pension and wages.

We currently have two cases filed for arbitration, one with Certainteed Roofing and one with Stop & Shop. These cases, both of which are for wrongful termination, were heard last month and we are awaiting the arbitrator's decisions. Hopefully we'll have good news to report on their outcome. We also have a grievance scheduled to be heard this fall regarding a pay issue at the American Red Cross.

An agreement was reached with Stop & Shop to raise the new hire rate from \$12/hour to \$14/hour at the warehouse in Freetown. This agreement also brought up the pay of over 100 current associates who had not yet hit \$14/hour in their wage progression. This should help with both new-member recruitment as well as with retaining current members with the Amazon warehouse moving in down the street from the warehouse. We are now \$1.25 above Amazon's starting rate, plus, Stop & Shop offers company-paid union medical/dental and vision benefits and a top rate defined benefit pension.

Our members at Stop & Shop and Manfi Leasing made it through their busiest summer yet. Volume at the warehouse is up and our members stepped up to the plate and delivered every time. Your hard work and dedication as you work countless hours of mandatory overtime to meet the high demands of the company and its customers is greatly appreciated. You continue to show day in and day out why Teamsters do it better!

In closing, as always I'd like to thank all of my stewards for their hard work this summer and staying vigilant in their workplaces as we spent 18 weeks on the picket line fighting the corporate bully known as ABC Supply. I appreciate everything you do for this local and our members. Don't forget to stop by the union hall on the fourth Saturday of each month (except December) and support the Local 25 blood bank. Also, don't forget about your cash and toy donations in support of the Local 25 toy drive. Let's make sure that no child in the Boston area goes without at Christmas time. Have a happy and safe holiday season!



# Business Agent Joan Corey

As we all know, Local 25 spent the vast majority of this past spring and summer supporting our members on strike at ABC Supply Company. I can never say enough about how the men, "the GUYS," and all their supporters, were committed and

held together in the truest sense of solidarity. And, I can never say enough about the steadfast determination of President O'Brien and BA Murphy. Let us never forget Paul Lavoie. As stated during his memorial service, Paul was fighting for and alongside his union, to protect his family and his job. May Paul forever rest in peace!

I'm proud to report that we have ratified several contracts recently. Carpenter & Paterson Inc. in Woburn is a newly organized group thanks to the efforts of Chris Smolinsky, and consists of warehouseman and drivers. Thanks to stewards Ryan Long and Danny McCarthy, members now have a solid three-year contract that includes immediate wage increases ranging from 20-30 percent based on years of service and annual adjustments, overtime pay after eight hours, reduced health insurance costs, Teamsters Pension Fund and more.

Members at DSM Neo Resins in Wilmington ratified a five-year contract for plant operators and mechanics. Thank you to the team of Pete Ventura, Bill French, Tom Matley and Shane Boivin, who helped attain base wage increases, license/education incentives, and shift differential increases. The company will also now contribute to the Teamsters Local 25 Training Fund.

We also ratified contracts with 911 Dispatchers for the city of Chelsea and town of Concord. Thank you to Cathy Deruosi and Peter Sturgis for their involvement in the negotiation process for Chelsea. Some of the improvements include increased wages, holiday pay, sick leave incentive,

clothing allowance and the creation of a new lead dispatcher. In Concord, steward Nancy Campbell and I worked continuously, for many months, battling it out with the town. Campbell never lost sight of what was in the best interest of the unit and I'm proud to represent all of you.

In October, Chelsea Emergency E911 Dispatchers were united, when they chose to stand before Chelsea City Council to address their working conditions and concerns within the Emergency Operations Center. Our members displayed courage and integrity as they enlightened the City about their profession, often noted as one of the most stressful professions in the country.

In 2015, we ratified a three-year contract for the Melrose School Administrators Directors and Vice Principals. Five months later we were back at the table negotiating a Reorganization of Directors and Vice Principals due to the residents of Melrose voting down a school override. This most recent agreement is a one-year pilot program that will need to be reopened in the spring of 2017. Thank you to all our members who work extremely hard to provide a great education to the students of Melrose High School.

I am currently in negotiations with the following: Brookline Emergency Telecommunications 911 Dispatchers, Concord Public Works Department Employees, East Boston Neighborhood Health Center Drivers, Saugus 911 Dispatchers, Somerville Housing Authority Police Officers, South Shore Regional Emergency Communications Center Dispatchers and Supervisors, Respiratory Therapists at Whidden Hospital, and the City of Everett Clerical Unit and Emergency 911 Dispatchers. I also have several pending arbitrations open for unjust terminations.

This fall I look forward to spending more time out in the field, having a presence in the workplace as much as possible, to gain the best understanding of your work environment. Thank you to all members that provide continued support to the labor movement and all that it represents.

In closing, the Women's Committee is in the midst of HELPING THOSE IN NEED with a simple gesture of collecting new socks for the homeless. New socks for men, women and children are the number-one needed item for the homeless. #### On a Mission, One Bike at a Time

ember Steve De Angelis works at Republic Services in Revere. In his spare time, he and his wife Kelly help their 7-year-old son, known as Bug, manage his nonprofit Bug's Bikes. The charity that donates disability bikes to children was born out of a lemonade stand. Bug's mission is simple—to provide "bikes like mine, for kids like me."

Bug is visually impaired with high functioning autism and medical complexities. He loves riding his bike. Unfortunately, for many kids the cost for an adaptive bike is out of reach. Basic adaptive bikes can run between \$600 to as high as \$3,000 or more.

"When I stopped by the union hall, I was just going to drop off some fliers for our event," said Steve De Angelis. "Local 25 stepped up to the plate immediately, providing a donation and sending the truck to our fundraiser. All of the children—and adults—loved seeing the truck, but more importantly, Local 25's participation sent a strong message about commitment to our community. Thank you President O'Brien!"



## O'Brien Tells Convention **About Importance of Preparing Future Generations**

**Local 25 Futures Committee Gets Recognition** 

resident Sean M. O'Brien addressed the 29th International Teamsters Convention in late June, telling attendees about the importance of educating and preparing the next generation of union leaders to take on the big fights that lie ahead.

O'Brien, who noted he is a fourth-generation Teamster, said the union has meant everything to him and his family.

"Everything my family and I have had in our entire lives is because of the greatest organization in the country, the International Brotherhood of Teamsters," O'Brien said.

O'Brien said he has seen a general erosion of knowledge over the years about the struggles union members have endured, which led him to create the Futures Committee. The purpose of the Committee is to educate and prepare young union members for the challenges down the road.

Futures members, who are 35 and younger, have volunteered for political action events, organizing campaigns and have followed Business Agents on the job to get an understanding of their jobs.

O'Brien said he wants to put the corporate "bullies and fat

ready to fight on behalf of workers, and he challenged union leaders to take part in the effort.

"It's our obligation, as leaders, that we educate the next generation of Teamsters," O'Brien said. "This next generation needs to be bigger, faster, stronger in order to fight the battles that are ahead of us."

#### Other Highlights

Once again, the Teamsters Local 25 tractor-trailer rig made the journey to Las Vegas for the Convention, and took part in the parade of trucks along Las Vegas Boulevard.

Also, Local 25 joined Teamster leaders from across the country in donating money to a nonprofit group founded by Travis Bornstein, President of Teamsters Local 24 in Akron, Ohio. Bornstein made an emotional presentation about his son, who died from a heroin overdose in 2014 at age 23. The group, Breaking Barriers—Hope is Alive, was set up to raise awareness about heroin addiction.

# V/CTORY at ABC Supply Company

Members Stand Strong 125 Days on the Picket Line to Prevail

t was a long, hot summer for the members of ABC Supply Company who were on strike for months.

"On May 7, we made a decision and the decision was tough – the decision to strike. I think as union leaders, we all say that's a last resort – but it was necessary," President O'Brien told hundreds of labor leaders at a Labor Day breakfast in Boston. "This is the fight of our life. And it's not just about ABC workers – it's about the entire labor movement."

Following several rounds of contentious contract negotiations with the company, the 26-worker unit voted to strike after the company attempted to pull out of the New England Teamsters Pension Fund. The members, with the support of other Local 25 members, staffed the picket line at four locations 24-hours a day, seven days a week, to defend their right to maintain a pension plan.

Two months into the strike, members suffered a devastating loss, when Paul Lavoie died suddenly on July 8. He worked at the Chelmsford facility. Age 46, Paul left behind a wife, two children, one grandchild and his father.

"It was a tough summer, with some dark days along the way," said Harry Lang, a crane operator with the company for 21 years. "But we never doubted the leadership of Local 25. They stood up to the employer, never backed down and got us a fair contract."

We ratified a contract on September 8. The contract is a five-year deal with wage increases, bonuses and additional benefits. Members will receive \$11,396 more per year, not including overtime.

"We never felt like it was just us, the members from ABC Supply, on strike. Members would stop by after work or days off to show their support, and that meant a lot," said Lang.

Several other labor unions joined members throughout the summer including Mass Nurses Association and the Greater Boston Labor Council.



# Need medical care? Your first and best action is to contact your Primary Care Physician. If your doctor's office is closed, you have options:

- 24-Hour Nurse Care Line/ Blue Care Line (888) 247-2583

  Have a medical question or need some medical advice? If you are enrolled in a Blue Cross Blue Shield medical option through Teamsters Care, you have the benefit of consulting with a Nurse by telephone, 24 hours a day/7 days a week for medical advice.
- *Use Telehealth* for a real time on-line video visit with a doctor for many common conditions. Available 24 hours a day/7 days a week with a \$15 co-pay for TeamstersCare medical option members. Visit <a href="https://www.bluecrossma.com/telehealth">www.bluecrossma.com/telehealth</a> for more info.
- Visit a "Limited Service Clinic". Usually located within retail pharmacies, these are available to treat simple medical concerns and are available days, evenings and weekends for an office copay of \$15 (for TeamstersCare medical option members).
- *Urgent Care Centers* are local clinics that treat conditions that aren't life threatening but require immediate treatment. Examples are broken bones, stitches and minor injuries. Available days, evenings and weekends the office copay is just \$15 (for TeamstersCare medical option members).
- The Emergency Room should be reserved for life threatening emergencies. Of the TeamstersCare Members who visited an emergency room last year, 67% of them were treated for non-emergency conditions. The wait time for treatment is much longer than for Limited Service Clinics and Urgent Care Centers and the co-pays are higher for emergency room visits \$75 for Active Members and \$100 for Early Retirees in the TeamstersCare Medical Option.

### Your TeamstersCare Pharmacists Talk **Antibiotics:** When They Can and Can't Help

#### What Are Antibiotics?

Antibiotics are prescription medications that are used to treat infections. They only work against infections caused by bacteria, fungi and certain parasites. Antibiotics don't work against infections caused by viruses.

#### How Do I Know When I Need Antibiotics?

The answer depends on what is causing your infection. The following are some basic guidelines:

- Colds and Flu. Viruses cause these illnesses. They can't be helped or cured with antibiotics.
- Cough or bronchitis. Viruses almost always cause these. However, if you have a problem with your lungs or an illness that lasts a long time, there may be bacteria involved. In this case your doctor may decide to try treatment with an antibiotic.
- Sore throat. Most are caused by viruses and antibiotics won't help. However, if your doctor determines that you have a strep infection in your throat, s/he will recommend treatment with an antibiotic because strep is a bacteria.
- Ear infections. There are several types of ear infections. Most are viral but, if your doctor determines that bacteria are the cause, s/he will prescribe an antibiotic.
- Sinus Infections. Antibiotics are often used to treat sinus infections. If you suffer from frequent sinus infections, your doctor may also recommend using a Nettie pot to rinse your sinuses with salt and (distilled) water.

#### What Else Do I Need to Know?

- If your doctor does prescribe an antibiotic for you, make sure you take all of the medicine, even if you start to feel better after a few days. This will reduce the chance that there will be any bacteria left in your body which may become resistant to future treatment with antibiotics.
- Never take antibiotics without a prescription.



## Local 25 Women's Committee Participates in 16th Annual Women's Conference

en members from Teamsters Local 25 joined their sisters from across the country and Canada for a three-day conference this fall that included workshops, general session speakers, and a chance for sisters to meet with sisters and share stories of managing a work-life balance.

"It's great to be in a room full of people who know how to get the job done, and that's Teamster women," IBT General Secretary-Treasurer Ken Hall said to thunderous applause.

California Assemblywoman Lorena Gonzalez, a former labor organizer and Teamster, echoed that sentiment. "Women need to be at the table. We need your voice – women's voice in the workplace, in the union and in politics."

The conference – attended by 1,300 women – included workshops on leadership, the collective bargaining process and stress management. Members also rallied in front of the TCL Chinese Theatre on Hollywood Boulevard to call on the University of California to deliver a fair contract for Local 2010, which represents more than 14,000 members on campus.

"Whether it's connecting with our sisters in Joint Council 10 from across New England or across the country at this conference, it's important for women to share their stories and bond with one another," said Business Agent Joan Corey, who chairs the Local 25 Women's Committee. "I'm continually amazed by the courage and sheer determination our women members bring to the bargaining table, our charities and political action."






