# Message from the President

#### **Dear Brothers and Sisters:**

This winter and spring has been very busy at Local 25.

On April 1, more than 800 guests attended the Boch Center Wang Theatre for the Teamsters Local 25 Autism Fund's 10th annual Autism Gala. This event has become the premier night out for not just our members and friends, but the New England autism community. It was truly an historic evening: We topped the \$4-million mark in fundraising and our honoree personified the strides people with autism have made. Local 25 is committed to this issue and know we still have a lot of work to do on the autism front. We are just getting started.

On April 12, Local 25 won an arbitration case against UPS. The arbitrator found UPS in violation of Article 20, Sections 2 and 3 of the National Master Agreement and awarded retroactive pay for our member, a UPS package driver. It was a significant decision by the arbitrator because it addresses an issue Local 25 and local unions across the country have encountered. Arbitrator Mark M. Grossman noted that UPS violated the contract by not allowing the worker to return to work after his doctor released him and refusing to proceed to a third doctor. UPS was ordered to pay the worker retroactively, covering the period from when his doctor released him to work to when he was permitted by the company to return to work.

Earlier in the year we held our steward's seminar. Thank you to all our stewards who attended and work so hard to keep our members informed. Stewards are often the first people a new worker meets and stewards help them navigate their new job and inform members how the union helps them.

This winter the Local 25 Women's Committee, in partnership with the Joint Council 10 Women's Committee, and the national foundation Sock-It-To-'Em, collected socks for those in need. Our members and business agents accepted the challenge to provide warm socks to local shelters, churches and veterans groups. I'm proud to report that together Local 25 collected more than 11,000 socks that were then distributed back into our communities. It was truly a team effort!



# Officers' Reports



Secretary-Treasurer Tom Mari

Since my last report, we have ratified the Boston Trade Show agreement by a 90 percent margin. This agreement covers over 20 different companies in the industry where we have over 500

members. The agreement has many improvements, including \$5.75 in wage increases over the five-year deal, 100 percent paid Teamster health and welfare, Teamsters pension fund and annuity at \$6 per hour (company paid). We also increased the warehouse rate by \$11.65 per hour—the new rate will be \$38.65 per hour. We were also able to require the companies to re-hire any referral member who was previously discharged. Our work rules, benefits and wages are the highest throughout the United States. Once again, we have achieved the most superior Teamster Trade Show agreement in the country. I want to thank the members and the negotiating committee for all their support.

At UPS, we have many issues we are tackling this spring. It is a constant battle policing the contract on 9/5 work day, supervisors working and the changes with Tuesday through Saturday work week. Our stewards in all of the UPS buildings at Local 25 are working tirelessly to enforce the contract and I want to thank them for all their hard work.

In the Oil Division, we have many issues on the horizon. We have some agreements expiring in 2017 and the majority will expire in 2018. We encourage all Oil Division members to start saving some money in preparation for the upcoming contracts. As the new agent for this division, I've found that most companies want to test the local and they are finding out that our members come first no matter what!

In closing remember this: "Together we Win, Divided we Beg."



Vice President Steve South

We are currently in negotiations with Boston Pipe and Supply (newly organized), Watertown DPW, WB Mason (newly organized), City of Waltham DPW (newly organized), and the City of Med-

ford School Security Monitors (newly organized). We had a proposal meeting for Independent Pipe and Supply for the contract that expires on July 31. We have also scheduled a proposal meeting for our members at MS Walker for the contract that expires on October 31.

In the moving and storage industry, we have been working very hard to enforce the "community standards" in the cities of Boston and Cambridge. Please make sure that when you see nonunion movers in Massachusetts you tell them about the Teamsters pay and benefits at the union moving companies.

In March, I attended the UPS/UPS Freight Panels in San Antonio, Texas. At UPS, we have filed numerous unfair labor practice charges at the National Labor Relations Board (NLRB) regarding the following illegal conduct by the company: negotiating directly with union members, discriminating against our members as retaliation for their union activity, and implementing new policies and procedures without negotiating with the union.

We also continue to have serious issues at UPS with dangerous safety conditions, injuries not being reported properly and timely, union members being refused medical treatment, union members not being paid for time worked, and many payroll issues. If you are injured, it is important that you report the injury to your steward and your supervisor immediately. Management is required to provide you with transportation to and from the nearest medical facility for treatment. Do NOT ever allow a supervisor, manager or insurance company representative into the examination room with you, even though they often ask.

If your workers' compensation claim is denied by the company, contact the Keches Law Group at (508) 822-2000. I encourage all employees to write down your start and finish times each day and make sure your paycheck is correct each week as the company often makes mistakes with payroll. All employees are required to take a one (1) hour lunch each day unless you are getting a paid lunch. During your lunch hour it is illegal (Mass. Attorney General's Wage and Hour Laws) to make deliveries or perform any other work as you would then be working for free. It is also illegal to work for free before or after you have punched out. The company has fired many employees recently for working "while on lunch."

I would like to welcome Maurice Richard and James Carfagno who are new stewards in the UPS Chelmsford Hub.

Lastly, I want to thank IBT Package Director Sean M. O'Brien for appointing me as the Eastern Region Chairman of the Package Division effective April 1. I look forward to the upcoming negotiations and appreciate the opportunity. Have a great spring!



# Business Agent John Murphy

National contract negotiations with DHL and AEI Global Forwarding have reached the supplemental agreement issues. The committee has nearly completed the national contract issues, and we will meet one

more time at the end of April in Philadelphia with both companies to clean up the National, then on to the Supplements. AEI is looking for concessions in the National as well as the Supplements in the form of sub-contracting union work to non-union stations, cutting accrued time off and a two-tier wage progression topping out at 75 percent of the top rate.

DHL is still looking to expand the use of part-timers, some working only three days a week, and other five days to include driving 24/7 for deliveries and pick-ups, weekends at straight time and a two-tier wage progression.

Negotiations at Cambridge Offset Printing are completed with a 5% wage increase and the MOB of our pension.

We have received the information that we requested from Xpedx/Veritiv on their plan to close the Wilmington operation, and have been reviewing it to try and help us keep this operation here in Local 25's jurisdiction. With the help of President O'Brien and Jim Donovan and our attorney, Mike Feinberg, and Tom Curtin of the IBT we have reached out to the state Office of Economic Development to help find commercial property in Massachusetts to keep the company operating here,

as well as sending letters to their customers and shareholders such as Bain Capital and The Baupost Group LLC. We will get back with the company in the next couple of weeks.

In the Freight Division, I will be traveling to Overland Park, Kansas the second week in April with the Freight Division Director Ernie Soehl and the Division's attorney, Rich Gibson, to meet with YRC Chief Executive Officer James Welch, to talk about the financial stability and upcoming contract negotiations with this company.

# **Business Agent Robert Aiguier, Jr.**

I'd like to start by congratulating President Sean O'Brien for being appointed the Director of the Teamsters Package Division, and becoming the Secretary-Treasurer and Principal Officer of Joint

Council 10. I'm proud to serve under such a dedicated advocate for the working families of the Teamsters Union.

We've been busy with negotiations since my last report. In the Parking Division, we negotiated and ratified three separate contracts covering SP+, ProPark, and Impark. All three agreements run until 2020 and include wage increases of 4 percent the first year, 3 percent each additional year, company-paid training fund contributions giving the workers a path to obtaining their CDL, and we maintained pension contributions.

We've also negotiated a couple contracts with our Building Services companies. The members at Emerald Green and UG2 ratified deals that run until 2020. In these agreements, we negotiated a wage increase of 12 percent over the life of the agreement, gained an additional paid personal day for a total of eight per year, added company-paid training fund contributions and 100 percent company-paid Teamsters Dental and Vision benefits, and we maintained pension contributions. I'd like to thank my steward, Zoila Perez, for her help at the bargaining table.

The members at Marr Scaffolding recently ratified a new CBA that will continue both company-paid Teamsters

Health and Pension contributions until 2022. The members will also receive wage increases of \$3.50 per hour over the life of the agreement.

I picked up a new assignment with the Rigging Division. I look forward to working with the stewards and serving the working families of Local 25.

When parking in and around Boston, remember our brothers and sisters in the parking industry. Let them know you're a Teamster! Current Local 25 parking companies are VPNE Parking Solutions, ProPark, ImPark, SPplus, and LAZ Parking. A map of Teamster parking facilities can be found on the Local 25 website. Please continue to boycott all Pilgrim Parking locations until they agree to give their workers a voice in the work place.



**Business** Agent Jason Lopes

I'd like to start by thanking President O'Brien for his support by appointing me as a representative for the Public Services Division nationally. I look forward to serving our members in the public sector

and representing Local 25 on the national level.

On the negotiating front, we are still in negotiations with the American Red Cross for the nine newly organized biomedical technicians. Under the national contract, they will be enjoying yearly raises, a comprehensive union health insurance plan and job protections. Negotiations have also started with Americold Logistics, UMass-Boston Police, UMass-Lowell Police, and the City of Cambridge. I hope to be reporting on successful negotiations ahead resulting in strong successor agreements for these groups in my next report.

A new five-year agreement was overwhelmingly ratified by our members at Certainteed Roofing in Norwood. This new agreement provides wage increases and protects their top-of-the-industry health insurance and pension benefits. A five-year agreement was also unanimously ratified by our members at Aramark Management Services at Mt. Ida College. This newly ratified agreement provides wage increases upwards of 10 percent in year one to help bring our members in line with market rates, with 3 percent increases in the following four years of the deal.

We currently have one case filed for arbitration with the

City of Cambridge for a refusal to pay overtime. We were able to settle the national grievance that we had filed with the American Red Cross. This settlement distributes over \$18,000 to our aggrieved members for a miscalculation of overtime pay when using personal and sick time.

An agreement was reached with Stop & Shop to raise the new hire rate again, this time from \$14 per hour to \$15 per hour at the warehouse in Freetown. This should help with new-member recruitment as well as with retaining current members who otherwise may have considered working at the Amazon warehouse down the street. These warehouse jobs provide company-paid union medical/dental and vision benefits, short-term disability, life insurance and a top rate defined-benefit pension accrual. Anyone looking for a great job with the opportunity to provide for their family with good wages and excellent insurance and pension benefits should reach out to me here at the local for details on how to apply. We are still looking to fill 50 full-time positions.

Our members at Stop & Shop and Manfi Leasing in Freetown suffered a tragic loss this past January with the passing of brother Alphonse Ferent. Brother Ferent was tragically killed in a warehouse accident during his shift as a dockworker. Please join me and the rest of our Teamsters family as we keep the Ferent family in our thoughts and prayers. Alphonse's dedication and service to this local union will never be forgotten and may he rest in peace.

In closing, I'd like to congratulate President O'Brien on his appointment as Director of the Package Division. Your hard work and dedication continue to be rewarded and it's an honor to serve as a part of your team at the greatest local in the country. Also, don't forget to stop by the union hall on the fourth Saturday of each month (except in June, July & August) and support the Local 25 Blood Bank. Have a great spring everyone!



Business Agent **Joan Corey** 

Since my last report, with the dedication of steward James Caron and the support of all, the city of Chelsea Public Work Specialists ratified a three-year agreement. Improvements included call-back pay minimums,

compensation at time and one-half pay for hours worked when

the city suspends city business due to an emergency and employees of this unit are required to work. We also won wage increases of 8.5 percent with the creation of at least two Senior Licensed Public Work Specialist Positions and a Senior Foreman Position, resulting in advancement opportunities and additional wage increases of 3 percent and 4 percent. Also, we achieved double-time pay or compensatory time for all holidays worked and an incentive to earn extra vacation days if employees work all snow storms. Now all employees will accrue the same amount of sick leave, up to twelve (12) days annually. The sick leave incentive bonus was increased and there is the potential to earn up to \$1,200 annually for perfect attendance. The city will pay the costs of the medical certification for CDLs, costs to obtain initial a CDL and the continuing education classes for hoisting licenses. There is also language addressing if and when the city implements the use of a (GPS) system on all city-owned vehicles.

I worked with steward Sean Browne during contract negotiations for the Somerville Housing Authority police officers. The new three-year agreement includes an annual wage increase, minimum four-hour overtime or compensatory time for court appearances, addition of employee's birthday as a holiday, increased number of personal days based on years of service, new clothing allowance and increases to longevity schedules. The employer also agreed to one paid day a year for cancer screening, and reimburse for the purchase of eyeglasses up to \$350.

The members at Whidden Hospital/Cambridge Health Alliance unanimously ratified a three-year contract which includes wage parity with other affiliated Cambridge Health Alliance Hospitals. The significant wage increases were achieved through modifications to step increases. These members are respiratory therapists and I'd like to thank stewards Allen Panarese and Daniel Grunst who helped with neogitaitons.

Last November, Local 25 filed charges with the Massachusetts Department of Labor alleging the town of Saugus engaged in prohibited practices. In March, an in-person investigation was conducted, and last month the Department of Labor Investigation concluded that probable cause violations have occurred on four counts. The town was ordered to respond to all counts within 10 days, an expedited hearing and mandatory mediation. Steward Cheryl Kenney and John Donachie have provided great leadership and support. We will continue to work over the coming months to ensure our members' rights are protected and they receive all the benefits that are provided through the collective bargaining process. The union has also filed for arbitration to cease and desist attempts to outsource our members'

work. When our members stand together we succeed.

Negotiations continue with the city Boston, SSRECC Dispatchers and Supervisors, city of Everett Clerical and E911 Dispatchers, town of Brookline and town of Concord. I will begin negotiations soon with East Boston Neighborhood Health Cneter, city of Cambridge, town of Winthrop and Golden Living Nursing Facility.

I'm happy to report that a 30-year member of Hertz recently received an arbitration award to be reinstated to his former position based on an unjust termination. We also recently resolved and settled all four pending arbitrations. Thank you to stewards Ed Neri, Juan Bonilla, Dennis Lemard and Stephanie DiMauro.

In closing, I'd like to thank the staff at TeamstersCare who have helped many members I represent with outstanding service over the past six months. Leslie Russell, Larry Libby and Mark Staniul continue to work quietly and calmly behind the scenes to help our members and their families. Thank you President O'Brien for recognizing the importance of services offered to members via TeamstersCare.



# Business Agent Andrew Walsh

Since being appointed Business Agent this past October, I have been able to meet many new members and represent them in many different industries.

Our members at United Airlines

have ratified their contract that includes language improvements, wage increases that keep our members 2 percent above the industry average every two years during the term of the agreement, lump sum retroactive checks and furlough protection for our members.

The town of Hingham DPW Supervisors unanimously ratified their new contract. This is a new group with a first contract. Our members will receive wage increases over the term of the agreement, better work rules, and finally be covered by a collective bargaining agreement. The Hingham DPW contract has been expired and dates have been discussed with the town to begin these negotiations.

At Waldo Bros., a building material supply company, we have reached a tentative agreement as of this report which

keeps our members in TeamstersCare dental and vision, wage increases and a better holiday schedule for the group.

I have negotiations with Crown Services, Admiral Metals, P. Gioioso & Gioioso Bros., Capitol Waste and Jet-A-Way over the next few months.

I had the opportunity to work with Business Agent Bob Aiguier in the Building Trades and have been able to get Carney Recycling onto a Shawmut construction job at UMass-Boston replacing Charles George, a non-union company. Construction is strong in the city of Boston I will be trying to get our members as much dumpster work as possible.

In closing, I would like to thank all the members for the support you have shown me and all the stewards for introducing me to the members and the industries that you represent. Our members work hard under tough situations and I am proud to call you brothers and sisters.

Congratulations to President O'Brien on his appointment to lead the Teamsters Package Division. As a UPS worker for the past 23 years, there is no one other than President O'Brien I would want leading this

division and fighting for our rights.

Congratulations to President O'Brien in his new appointment as Director of the Teamsters Package Division.

In an industry that is new to Local 25 we successfully organized a group of Petroleum Inspectors at Camin Cargo Control in Everett and we were certified as their exclusive bargaining representative as of March 27. We also organized a group of warehouse workers at Interstate Office Partitions in Wilmington, adding new members to our moving, storage and warehouse industries. Once certified they will be on their way to ratifying the strong Teamsters Local 25 contract that they deserve.

Lastly, I can't stress enough the importance of internally organizing our own membership and preparing them for the battles that lie ahead. The deck is stacked against us, with bad trade deals, weak worker protections and the threat of so-call National Right To Work, and we need to be prepared to take on whatever comes our way. ### TEAMSTER STRONG

major cases, one at UPS and the other at W.B. Mason.

Six workers at Camin Cargo Control in Everett and nine workers at AmSpec Services, LLC, also in Everett, voted to join Local 25.

"The leadership of Teamsters Local 25 showed our workers great respect from day one," said Abdelkader Makhlouf, a worker at Camin Cargo. "The focus was always on what we wanted, how they could help us, what being part of the union means, and how they would always be in our corner fighting for us. Even though we are just a group of six workers joining a family 11,000-plus strong, we know that our voices will matter and will always be heard."

#### Victories at UPS, W.B. Mason

On April 12, an arbitrator ruled in favor of Teamsters Local 25 in a case involving a UPS package driver who was injured and not permitted to work despite being released by his doctor. The arbitrator found UPS in violation of Article 20, Sections 2 and 3 of the National Master Agreement and awarded retroactive pay for John Perry, the driver involved in the case.

Perry, a package delivery driver, injured his shoulder while lifting a heavy garage door in late 2014. He was on a workers' comp leave of absence and, after physical therapy did not improve the injury, he had shoulder surgery in April 2015. He was cleared to return to work without restriction but UPS insisted he get ultimately two additional evaluations which resulted in nearly six months of not being able to work.

At W.B. Mason, on Nov. 4, 2016, an administrative law judge from the National Labor Relations Board sided with Teamsters Local 25 and found W.B. Mason guilty of numerous, serious unfair labor practices during an organizing drive. The judge stated, "Because of [W.B. Mason's] egregious and widespread misconduct, demonstrating a general disregard for the employee's fundamental rights, I find it necessary to issue a broad order requiring [W.B. Mason] to cease and desist from infringing in any other manner on rights guaranteed employees by Section 7 of the Act."

The judge also ordered W.B. Mason to recognize and bargain with Local 25 and issue the reinstatement of the five fired employees along with back pay and lost wages.

With this victory, Local 25 proved that the company violated federal labor laws and was able to help all five of the workers get a fair settlement.



# Local 25 Autism Fundraising Tops \$4 Million

eamsters Local 25 celebrated our 10th annual Autism Gala with a new venue, three bands, several hundred guests and shining a light on the amazing things that people with autism are capable of.

President Sean O'Brien presented the 2017 Essential Puzzle Piece Award to Marshfield resident Nicholas Landry. The 29-year-old was diagnosed with Asperger's Syndrome at the age of 12, and is a graduate of the Marshfield Public Schools and Emmanuel College, with a degree in history. An avid sports fan, he was the manager of the Emmanuel College Women's Basketball team that won four consecutive conference championships and advanced to the NCAA Division III Tournament during his tenure. He earned his teacher's license in 2012 and has been working as a substitute teacher since. His goal is to be a secondary social studies teacher.

"Nick is a true inspiration to all of us," said O'Brien.
"He has always faced his challenges head on and because of it today he has a college degree and his state teacher's license and is on his way to becoming a teacher. In the last 10 years, we've honored government leaders, celebrities with ties to autism, and those that work with people with autism, but this is really special. Nick Landry isn't just living with autism, he is thriving."

Landry thanked his large support system that includes

his family, doctors, teachers and coaches, saying he was "humbled" by the recognition. "I just try to be the best person that I can be."

This year's gala took place at the historic Boch Center Wang Theatre in Boston and guests were treated to three floors of dinner stations, chocolate fountains and good conversation. Highlights of the silent auction included a catered party for 20 guests, sports memorabilia and the chance to hang out with Tom Brady at the Harvard football stadium. A "roving bingo" replaced the spin to give guests on all floors the chance to win an item.

The Boston Higashi School Jazz Band welcomed guests as they entered. All of the students in the band are on the autism spectrum and for many, music has been their coping mechanism and the key to their success in all aspects of life. The Greater Boston Firefighters Pipes and Drum band opened the speaking program and then The Marsels had guests dancing the rest of the evening.

On April 20, the fund presented more than \$300,000 in grants to Autism Speaks, McLeans Hospital Autism Program, Braintree Challengers Little League, Jason Roberts Challenger Little League, Malden Challengers Little League, Norfolk County Day Camp, Stoneham Light it up Blue, Technology for Autism Now, and St. Francis Church in the name of Thomas W. Beckwith.

# Local 25 Helps Defeat Right to Work in New Hampshire

eamsters Local 25 worked with Teamsters Local 633 and Joint Council 10 earlier this year to send a strong message to big business in New Hampshire—but also across the country—that right to work is wrong and we will fight to stop this legislation in its tracks.

In a major victory for working people, the middle class and the state's economy, the New Hampshire House of Representatives voted February 16 to "indefinitely suspend" consideration of a right-to-work bill. The vote means right-to-work legislation cannot be considered again in the state for the remainder of the two-year legislative session.

"New Hampshire sent a very strong message: Right-to-work initiatives drive wages down and make it difficult for companies to attract employees," President O'Brien said. "We're very gratified that the House saw this bill for what it is: an attack on working people and a drag on the economy. Teamsters Local 633 worked extremely hard to raise awareness of the problems with this right-to-work bill, and the legislator's vote is a major victory

for Local 633, Teamsters across this nation, organized labor and the middle class. We're hopeful that the actions taken in New Hampshire will resonate for a long time and have an impact in other states considering damaging right-to-work legislation."

Local 25 helped Local 633 execute a grassroots campaign to educate members and all middle class families on what right to work really means. The campaign—from start to finish—included letters, emails and a major social media push. In fact, the victorious Facebook post went viral with more than 1,100 shares, 50-plus comments and ultimately reaching 155,000 people. Target legislators were identified and members were asked to call them and ask them to vote "no" on right to work. Leadership regularly provided statements to the media to keep the issue in the forefront during that time.

"It was a combination of traditional get-out-the-vote tactics like letters and phone calls and using social media to mobilize not just New Hampshire Teamsters but anyone who would be affected," said Jimmy Donovan Jr., Local 25 legislative director.


### Joseph Foti
