

Message from the President

Dear Brothers and Sisters:

As this issue goes to print, UPS members across the country will cast their vote in support or against the proposed UPS national and supplemental contracts. Local 25, and all locals in New England, worked collectively these past several months to deliver to our members a strong supplemental package that includes many improvements and no concessions. While the national agreement largely favors the company, the New England agreement benefits our members. We will continue to work tirelessly to make sure our members get what they deserve in all contracts.

Community service is a cornerstone of Local 25's legacy. Through the Teamsters Local 25 Autism Fund, we have raised millions of dollars and helped thousands of families affected by autism. Our tractor trailer attends more than 100 events each year at schools, fundraisers and community events. In addition, many of our members volunteer in their own communities. In this issue, we highlight many of the community initiatives we are involved with.

This spring, we awarded \$60,000 to 30 students as part of the annual Teamsters Local 25 Scholarship Program. These students are smart, curious, hardworking, and all come from Local 25 families! They represent the light in an often dark and uncertain world that we live in. I can't wait to see where their education takes them.

Last fall, Local 25 spearheaded a massive disaster relief effort when 13 trucks delivered 520 tons of donations to those in need after hurricane's in Texas, Florida and Puerto Rico. As this issue goes to print, hurricanes are again making landfall, and more closer to home, thousands have been displaced in the Merrimack Valley after a series of gas explosions tore through the area. Local 25 stands ready, as we always do, to provide help.

August 11 marked 12 years since I became president of Teamsters Local 25. We've had our share of challenges and victories but through it all the members have remained loyal and committed to our cause. At the September 16 membership meeting, our team was elected to another three-year term.

2019 will be equally or more challenging than this year. We again will be taking on corporations such as Stop & Shop and YRC. Our members in both industries are critical to the success of these campaigns. Winning strong contracts are the only options.

You have my word that we will continue to work harder than ever for you, our members.

Officers' Reports



Secretary-Treasurer Tom Mari

Since my last report in March, we have settled 12 contracts, most of which are in the oil industry. All of the oil agreements, including two each at Heating Oil Partners, Coan Oil, Needham Oil and Petroleum Heat and Power have all been ratified unanimously.

The members in this industry sent a message loud and clear that they will not stand for anything less than the best in the industry. These agreements all have 100% company paid Teamsters health and welfare and pension; we were also able to attain the largest yearly wage increases these members have had in the past 25 years. Thank you to all the stewards in this division for your support during these negotiations.

Also, in negotiations we settled Dry Ice Corp. with a fiveyear-deal with wage increases, Teamsters health and welfare and pension all covered. At Kraft Power, we have ratified a new five-year contract with wage increases, Teamsters health and welfare and doubled the increase of pension contributions. Mass Convention Center Authority Security Supervisors ratified a three-year agreement with 13.5% in wage increases over the three-year deal, including 10% of that on the first day of the agreement.

Shortly we will start negotiating the new agreements for Alliance Express and Brewer Petroleum. Proposal meetings will be conducted soon.

At UPS negotiations, the New England supplemental negotiations have concluded. The agreement has all improvements and no concessions. We were able to address many of the members proposed issues. President O'Brien's leadership in these negotiations was impressive. I wish I could say the same for the National agreement, but that is not the case. President O'Brien, John Murphy, Steve South and I traveled to Chicago in August for the UPS and UPS freight two-man committee meetings where we voted NO loud and clear because we will not support this tentative agreement as proposed.

On May 21, we unanimously ratified a one-year contract extension for the newly organized City of Newton DPW. The 178 Teamsters there received a two-percent raise with one year of retroactive pay as well as a \$350 dollar signing bonus.

We will begin negotiations on a new three-year agreement in October. Congratulations to the newly elected stewards there: Billy Conserva, John Taft, Josh Richardson, Manuel Oliveira, Robert McClary, Kendell Washington, Kevin Brooks, and chief steward Jeff O'Neil.

We are also in negotiations with the City of Medford: DPW, School Security guards/monitors, and School custodians.

At MS Walker in Norwood, 100% of driver helpers are now members of Teamsters Local 25. We have 40 new members as a result of this new provision in the CBA. On August 21 we presented an arbitration case on behalf of MS Walker members regarding the boot allowance and are waiting for the arbitrators decision. We also have many open unfair labor practice charges against the company for implementing new policies since the contract was ratified last year.

On April 19, we presented a case at AAA arbitration for a Teamster member who was unjustly terminated. The arbitrator put the member back to work with six months of back pay and benefits. Subsequently, the owner, Patrick Reardon, refused to pay the arbitrators award and terminated the member again. This company is the model for bad employers and we will hold them accountable at the NLRB, AAA, as well as federal court to fight for our members.

I have four new assignments: city of Chelsea 911, city of Everett Clerical, DPW, and 911. I look forward to working with all of the members and stewards in these cities.

At UPS, we have negotiated a new supplemental agreement covering the six New England States. This is a great supplement with many new improvements, including \$4.95 per hour more into the New England Teamsters Pension Fund. All New England locals are unanimously supporting it and recommend a YES vote.

This is very different from the new National Master UPS Agreement which includes many concessions, including a new two-tier wage system, increased subcontracting, giving up the eight hour guarantee for regular package car drivers, and allowing new technology that can potentially reduce bargaining unit work and jobs. We are pushing hard for a NO vote on this Concessionary Master Agreement.

As always, thank you to all of our hardworking brother and sister members as well as the stewards that represent them.

The UPS Freight National contract was discussed at a two-man meeting in Chicago the week of August 10 where three quarters of the leadership voted to send it to the full membership for a vote. Teamsters Local 25 leadership voted to send it

back to the table as we believe this contract is the worst contract our members could work under.

Sub-contracting was not adequately addressed, the company will still be allowed to give away 45% of our freight. Proposed wages were less than the last five years, including splits in all five years in January and July. New hires would never reach top rate, and members would have to work 300 hours more to accrue vacation and pension. This local has recommended a NO vote for all.

In the Freight Division, the ABF Freight contract was ratified nationally by almost 60% as our local voted no due to the pension and health and welfare issues. With the intervention of President O'Brien, our local was able to secure our members future by forcing the company to sign off on our health and welfare and pension increases to maintain our members standard of living.

At DHL Express, our grievance on the suspension of our members who honored the Local 251 picket line is now going to be heard at American Arbitration this fall. We are also fighting an NLRD charge in Boston because of this strike. I hope to have the current contract printed soon.

At Massport, contract negotiations are ongoing as we sit down with the labor department for our members at Logan, Hanscom and Worcester.

Our new Credit Union Branch in the Local 25 building has been a great success. Our members enjoy a more convenient location, with a new ATM machine in front of the building. It's now easier to do all your banking right here at your New England Teamsters Federal Credit Union.

In the Building Services Division, we were successful in settling a termination, pre-arbitration, that returned that member to work and made her whole for all lost wages and benefits for the ten weeks she was out.

We recently organized and negotiated a first contract for the drivers at J.C. Cannistraro. These employees will now join our brothers at Harrington Air Services and receive 100% company paid Teamsters health and welfare, a top rate pension providing a dignified retirement, strong language protecting working conditions, and a grievance procedure. These new members will also receive wage increases of up to \$15-per-hour upon ratification! Welcome to Local 25!

The rigging contract covering Shaughnessy, Marr, Glancy, O.B. Hill, and Atlantic Plant Maintenance was ratified unanimously. It's a five-year deal that includes an increase in the monthly annuity, maintains the Teamsters pension, 100% company paid Teamsters health and welfare, and provides wage increases of \$1-per-hour for the next five years. I'd like to thank my stewards at all five companies, and all the men that joined us at the negotiating table. The list is too long to mention. At one point we were 15 members strong on the good guys side of the table! It was a true team effort.

The members at Flush ratified their second collective bargaining agreement with major improvements. It's a fiveyear contract that rolled the "yardman" classification into the bargaining unit. We maintained pension contributions, 100% company paid Teamsters health and welfare, the company enter the Local 25 Training Fund, added a new boot allowance and a new Teamsters Annuity, added a new eight-week paid sabbatical at 15-years of service, negotiated wage increases of \$1-per-hour for each year of the CBA, and revived a ratification bonus of \$2,000 per employee. I'd like to thank brother Joe Silva for his help in getting this one done.

We also wrapped up negotiations at Waltham Lumber, with the members there ratifying a four-year contract. The company has entered the Local 25 Training Fund and the prepaid legal fund. We've improved the vacation schedule, added a "foul weather gear" allowance of \$200, maintained 100% company paid Teamsters health and welfare, and transitioned the company into the New Employer Pension. The contract also provides wage increases of between .50- and \$1.50-perhour each year depending on classification. Thank you to steward Paul Jacobs and brother Mike Barille for their work at the bargaining table.

BrandSafway has a new five-year collective bargaining agreement covering employees in both Massachusetts and Connecticut. It maintains 100% company paid Teamsters health and welfare, top rate pension, added a monthly annuity contribution, improved the paid time off article, and the company entered the Local 25 Training Fund. It also provides wage increases of \$1.15, \$1.00, \$1.00, \$1.00, and \$.75 over the five-years. Steward Harry Lang was instrumental in getting this deal wrapped up.

Also, steward Jack Bellevue and I sat down with Aggregate to negotiate a five-year CBA. It has the company entering the Local 25 Training Fund, added 40 hours of paid time off with unused time being paid out at the end of the year, improved the new hire wage rate, passed on the .50 cent yearly health and welfare increases on to the company, and maintained a top

rate pension. The wage increases are between .75-cents and \$1.25-each year based on classification. There is a new health and welfare article that is beneficial to members lower on the seniority list. For all employees who cannot otherwise qualify for coverage, the company will make hourly contributions equal to the difference between 400 hours and the hours actually paid, provided that the employee works at least one day during the quarter, and further provided that the employee does not refuse to accept or fail to show for more than three bookings in said quarter. Meaning you can work only one day in a quarter and the company will contribute 400 hours towards your health insurance!

As always, thank you to my stewards for your hard work and dedication representing the members in the workplace every day!

Since my last *Spokesman* report, contracts have been ratified in many workplaces.

In the town of Brookline, the public safety dispatchers ratified a three-year contract which included annual wage increases, senior step

adjustments, increased training pay each year and improved shift differentials. Thank you to negotiating committee steward Liz Williams and Jackie Carroll.

In the city of Everett, the clerical unit members ratified two agreements which included four-years of wage increases, a new top step, longevity increases, the option to choose compensatory time off or overtime wages, sick leave bonus pay increases, and additional bereavement leave days. Thank you steward's Maria Bussell and Lisa Lamonica for your dedication and commitment.

Also in the city of Everett, the emergency 911 dispatchers also unanimously ratified two agreements containing four-years of wage increases, a salary scale restructure which factored in years of service, added new steps, increased shift differentials and bereavement leave days. Many thanks to steward Paul Dobbins and Julie Schurko for their leadership and perseverance.

In the city of Boston, the stationary engineers, licensed steam firemen and chief power plant engineer unanimously ratified their first Teamsters contract. This included two agreements, a one-year and a three-year agreement totaling four-years of annual wage increases, the creation of a new top step, weekend differential increases, boot allowance increase and language updates. Steward Michael Keogh did a terrific job representing his co-workers at the negotiating table. The school administrators at Melrose Public Schools unanimously ratified their contract which included some job title changes and salary adjusted accordingly, annual wage increases, new language providing the members the option to work from home on limited days when students are not in session, new language allowing members the ability to rollover unused personal days into sick leave, additional personal day, increased sick leave accrual rate, full year administrators increased vacation time and the ability to carry over unused vacation time. Thank you to the negotiating team of Angela Singer, Cari Berman, Stephen Fogarty, and Jennifer Chernisky.

The school nurses in the town of Tewksbury unanimously ratified a three-year agreement with stipends now added to base wages, annual wage increases, two extra days, increased holiday and half days language in conjunction with professional development days, personal days, additional days off for bereavement leave, a new position created, increased percentage of buyback of unused sick time at time of retirement. Thank you to the negotiating team of steward Deb Kraytenberg and lead nurse Elaine Walsh - well done!

At St. Michael's Cemetery, the laborers and licensed operators unanimously ratified a five-year contract which includes annual wage increases for all classifications, Teamsters health and welfare and pension, and employees will now receive top rate pay after 12 months on the job. Thank you steward Shawn Powell for representing your team proud.

As a union, we join together to solve problems, and make changes that improve members lives and their communities. We strive for improvements at your workplace. Thank you for that opportunity.

I hope everyone enjoyed summer, it was definitely a busy one with many new agreements being ratified. We ratified new three-year contracts for our members in the UMass Lowell Police Department and the police lieutenants at UMass Boston. A new

five-year agreement was ratified by our members at Costa Fruit and Produce. This agreement provides wage increases and protects our members' top of the industry health and welfare and pension benefits. We also ratified new five-year contracts for members at D'Arrigo Bros., S. Strock, P. Tavila, Peter Condakes, Community Suffolk, Mutual Produce, S. Silk, and John Cerasuolo at the produce market in Chelsea.

On the negotiating front, we are currently in bargaining with the city of Cambridge ECC supervisors and the DPW department supervisors. The negotiations for a successor local and national contract with the American Red Cross have been ongoing since March, hopefully by the time you read this we will have reached a new agreement. Proposals meetings for DPI Dedicated Logistics, Stop & Shop warehouse and Manfi Leasing will all be occurring this fall in preparation of upcoming negotiations.

We currently have three cases filed for arbitration. Two of these cases, involving Manfi Leasing, will be heard by the New England Joint Area Committee at the October panel. The third case is a wrongful termination at Stop & Shop. Hopefully I will be reporting on favorable outcomes in all cases in future reports.

We had another successful spring and summer at the Stop & Shop Distribution Center in Freetown. Our over 900 drivers and warehousemen continue to provide top notch service for New England's largest grocery chain, proving yet again that Teamsters do it better. If anyone with a CDL license is interested in working at Stop & Shop give me a call at the union hall as we will have several spots to fill due to impending retirements. These jobs provide great wages, Teamsters health insurance and top rate pension contributions.

After a slow start to the year things are really taking off in the motion picture industry in Massachusetts. Equalizer 2, Little Women, Wonderland, Jungleland, and Sound of Metal are some of the projects our members have worked on this year. The movie work combined with commercials and the four episodic television series - SMILF, City on a Hill, The Hamelins and Castle Rock - should keep the industry booming right through 2019.

I'd like to take a minute to reiterate my appreciation for our hardworking men and women in municipal services. Our members in municipalities such as Cambridge and police departments like UMass Boston and UMass Lowell work tirelessly to keep their community running and safe. It's a privilege for me to represent such hardworking members. We will remain vigilant in this increasingly difficult environment to protect, preserve and improve on your well deserved and hard earned benefits.

We will be holding our monthly blood drives at the union hall this October and November. Please consider swinging by and donating to this life saving mission.

As always, thank you to my stewards for your tireless efforts in the workplace every day, it is your hard work and dedication on the front lines that gives the local the strength to succeed. It is an honor and a privilege to serve the members of this great local under President O'Brien's tremendous leadership.

I hope all of our members had a great summer. Since my last report we have been able to ratify a fiveyear contract at Arlington Coal and Lumber which includes a wage increase, a new boom truck classification, additional vacation time,

Teamsters health and welfare and pension. I would like to thank steward Mike Brenneman for being on the committee.

We also ratified a five-year contract with Romanow Container. The contract includes wage increases, and we were able to freeze the company health care at 10% for the life of the contract as well as maintain the Teamsters pension. I'd like to thank steward's Yves Villard and Mike Jewell, and Matt Silva.

As I write this report I am scheduling a ratification meeting for the Town of Hingham DPW. This was a long process, but we were able to secure 9.4% in wage increases, increased the weekend bonus pay and meal allowance, improved the holiday pay schedule and got the town to agree to double time wages for hours worked beyond 12 hours. We increased the longevity pay for all employees and added a class A stipend. We also improved some language in the contract. Thank you steward Jeff Madden, Scott Chapell and John Bibby.

At Sunrise Scavenger, the company asked Local 25 to enter negotiations early. The members agreed and I'm happy to report this resulted in improvements to the CBA. The CBA includes wage increases each year of the contract, and maintains Teamsters health and welfare and pension. We were able to negotiate employer paid pre-paid legal for the group. We also got the company to enter the Teamster's Local 25 Training Fund and better language for our members. Great job by steward Will Watson!

Aramark Uniform Services negotiations are ongoing, and Republic Waste Dispatchers negotiations has slowed over wages, health and welfare and pension. The Peter Pan Bus contract expires December 31 and we will be holding a proposal meeting to prepare for those negotiations.

Jet-A-Way Disposal has been sold but will work under the Jet-A-Way name. I have met with the new owner and he has stated that he wants to build this company back to where it was.

This summer I had the opportunity to work at Signature Flight Support. These members are responsible for all private aircraft that fly into Logan Airport. It was an education to see what these members do on a daily basis. This contract expires in November and we are preparing our proposals.

It is a privilege to work with our great members in representing this local union.

I hope everyone has enjoyed time with family and friends this summer. It has been a busy season at Local 25. The UPS national contract that was negotiated has many flaws that will harm our members here and throughout the country. The

hybrid 22.4 jobs will introduce a "second class" package driver with no excessive overtime protections and a lower rate of pay to perform the same work as regular package car drivers. This agreement also fails to help our part-time workforce or protect our feeder jobs from subcontracting. We have conducted many parking lot meetings to educate our members of the negative impact the national agreement will have on all classifications at UPS. The petition drive this summer was incredible. Our members have made it clear that they are voting NO on the national agreement.

Thanks to the leadership of President O'Brien, the New England Supplemental Agreement continues to be the best in the country. The company made many outrageous proposals including eliminating current holidays, flexibility to change driver job schedules, and eliminating 1/52 vacation pay. President O'Brien accomplished in New England, what our national leadership failed to do. With no concessions given to a very profitable company, he negotiated great language protecting drivers with an eight-hour guarantee, continued overtime on Sundays, improvements in Feeder Classification language, and peak season overtime for part-timers on a 6th punch.

Thanks to our stewards and members in all Local 25 buildings that continue to enforce our contract and grieve violations. We have settled and paid over 3,800 hours of subcontracting grievances in Chelmsford Feeders. This has resulted in at least 15 new jobs in the department this year. Prior to arbitration, we settled cases involving seniority rights to overtime and two terminations with members returning to work.

I continue to assist Vice President Steve South in the moving and storage division. At his direction, I have been visiting members working in the city of Boston and Cambridge on jobs and meeting with building managers within the city to maintain and increase our share of available work. Thanks to all the hardworking members in this industry for the support given to me this year.

In late July, I had the privilege to spend the day at the Boston Higashi School. President O'Brien drove the Local 25 tractor trailer to the school for the kids. It is an amazing facility, helping children and young adults with autism. The incredible work that the staff does is only matched by the wonderful students that work toward a brighter future. They truly are an inspiration to me.

I hope that everyone found time this summer to take a break from all your hard work to spend time with your families to appreciate what it really is that we all work so hard for. It has been a busy summer for the leadership team here at


Local 25 as we have been working hard to continue to negotiate strong Teamsters contracts at the table and represent our members in the workplace. Since my last report I am pleased to announce several successful contract ratifications and announce that I now have the honor of representing two new groups, Lindenmeyr Munroe in Bellingham and Horizon in Lynnfield.

At Medford CPL, with the help of steward Carlos Navarro, we successfully ratified a five-year agreement for the drivers who deliver Dunkin Donuts early mornings to the shops. We were able to gain another week's paid vacation as well as annual wage increases including a \$1 raise in the first year.

In Norwood at Norwal Corp, we ratified a five-year contract including annual wage increases, maintaining Teamsters pension and 100% employer paid TeamstersCare. Thank you to steward Brett Clapp for in help in those negotiations.

At SAF Sales in Wilmington, our members unanimously ratified a five-year agreement maintaining TeamstersCare, pension and annual wage increases throughout. Special thanks to Bobby O'Brien for his hard work in assisting to get a contract done in contentious negotiations with the company. The strength of that group showed that when push comes to shove, through solidarity, Local 25 will always come out on top.

This summer we were able to secure more theatre work for our members as we negotiated an agreement for the Colonial Theatre in Boston. The London based company, Ambassador Theatre Group, remodeled and reopened the Colonial and now we are in talks to secure a long-term agreement there. We are also currently working on successor agreements for both Wang Theatre and Shubert Theatre.



At New England Millwork, another successful ratification, thanks to steward Bryant Panora, that maintains TeamstersCare and pension as well as \$1 increases in all five years of the agreement.

After a long, hard fought battle, with the Boston Globe, an agreement was overwhelmingly ratified that allows our members in the newspaper industry to receive wage increases for the first time in over a decade. Special thanks to committee member's Jamie Mastro, Billy Haley and Jason Johnson, for their steadfast commitment to getting the contract done.

The contract includes a union health plan that increases coverage dramatically for members and their families. Our drivers will pay nothing toward their premiums and we eliminated all deductibles and decreased out-of-pocket costs across the board. The company will provide a generous match to member's 401K and they can take advantage of several annual retirement buyouts should they decide to retire. I became a Teamster as a driver for the Globe and represented the group back when we were Local 259 before we merged into this great local. It's no secret that this contract was very personal to me, and I would like to thank President O'Brien and the entire team for the guidance and direction to ensure we achieved a deal that these men deserved.

Speaking of the Local 259 merger, I would like to congratulate Tommy Kane and Gordon Lister of the Patriot Ledger who recently received their CDL drivers licenses after training at the Local 25 Tractor Trailer School.

We unanimously ratified a three-year contract for our members working for Mystic Island Transport at the Marshalls warehouse in Woburn. New steward Alexis Nunez was integral in securing an agreement that upgraded equipment protecting the safety of our members, wage increases and maintaining Teamsters health and welfare and pension.

As I write this report, we have a tentative agreement for our custodians at Norwell Schools. We are also working hard to reach an agreement for the newly organized group at National Express. Steward's John McAuley and Ricardo Acevado are steadfast in their commitment to achieve a fair first contract for the group of site supervisors there. Soon we will start negotiations for members at Penske Logistics, Good Year and Paul Revere Boston/UMass.

I recently had to file for arbitrations for two separate wrongful terminations for drivers working for The Ride at National Express. I am happy to report that Local 25 once again won the fight as both drivers received back pay with one driver reinstated to his position and the other moving on to another workplace. I currently have three more arbitrations for wrongful terminations filed against the company and Local 25 will continue to fight for our members there.

Please do not forget about our upcoming Toy Drive this Christmas. I would like to wish all of our members a safe and healthy fall.

As each day of 2018 passes workers' rights are being diminished. The Supreme court ruled in Janus vs AFSCME that public sector workers can choose whether or not to pay dues and still receive all the benefits of a CBA overturning a

40-year decision and SCOTUS ruled that companies can use arbitration clauses in employment contracts that prohibit workers from banding together to take legal action over workplace issues. The NLRB has become pro-business with all the new appointments and immediately began turning back the clock on workers. They overturned the "joint employer" ruling which made it easier for workers and unions to hold employers accountable for labor law violations by franchisees and subcontractors, along with specialty healthcare which allowed workers to organize smaller units, "micro units," within their workplace rather than their entire workplace. The Department of Labor overturned the Persuader Rule which required companies and union busters to file paperwork disclosing when they reached an agreement regarding activity to dissuade employees from forming a union.

The attack on workers and their rights to collectively take action to better their conditions are being eroded. Wages are stagnant and health care isn't an affordable option for most. Regardless of how well the stock market is doing, the middle class is eroding and corporate America is enjoying the benefits. It's never been more important for us to reach out to these workers and tell them the good news: there is hope and Teamsters Local 25 has your back!
