#### **Dear Brothers and Sisters:**

As a third-generation Teamster and a 30-year member, I have witnessed this great Local thrive since I was a kid watching my father work in the freight division, and the support you have shown me has been overwhelming. **Our members are the heartbeat of this union; your support for your union is unwavering, and I cannot wait to work with all of you to continue the mission of the greatest union.** 

Teamsters General President Sean M. O'Brien was sworn in on March 22. While we will miss him here at Local 25, the work he is doing at the International will benefit millions of working families for decades to come. It should come as no surprise that on Day One he hit the ground running, and shows no signs of slowing down. It's a new day at the Teamsters with General President O'Brien at the helm. I'm also proud that so many of our Local 25 Agents and Members will be playing integral roles in the new administration.

Since taking office, I have appointed Brian Hatch and Nancy Campbell as Field Representatives. Your Executive Board, along with our staff, has worked tirelessly through the transition. Teamsters Local 25 staff are truly the unsung heroes of this Local.

In January we hosted the 13th annual Teamsters Local 25 Autism Gala, and were able to award 11 non-profits with \$350,000 in grants. In April we brought back the Stewards Seminar in-house, and increased normal attendance by more than 60 percent. We are also back to holding monthly meetings inside our Union Hall instead of socially distanced outside. These types of events are what being a Teamster is all about: uniting the membership for good.

Teamsters kept America moving during the pandemic, and we cannot let corporate America forget that. We must use this momentum to organize and stay united. Together we are unstoppable.

Let me be clear: if we don't organize, we die. We believe there is opportunity within our current signatory companies to negotiate strong contracts, so that all employees see the benefit of joining Teamsters Local 25. Member involvement is essential.

On April 28 we held our annual Workers' Memorial Day Ceremony, and sadly two names were added to the Memorial. Paul Woodward and Michael Gagnon were both members of the Movie Division. We will continue to fight for safety protocols in contracts to honor their memory.

The strength of the membership is the secret formula we use here in Boston. **Our members are united, strong and I am proud to call you my Sisters and Brothers.** Let's continue to lead by example, and show everyone why we are the best of the best! Remember, TOGETHER WE WIN, DIVIDED WE BEG!

# Officers' Reports



### Secretary-Treasurer Steven J. South

We have completed a strong second Teamster contract for the City of Chelsea 911 Dispatch Supervisors. The new contract includes 3.5% yearly wage increases and other improvements and was ratified unanimously on April 20. We have also completed a first Teamster

contract for the newly organized Town of Stow DPW. The new contract provides for 3% yearly wage increases, Teamsters Dental/Vision, Training Fund contributions, and many other new benefits and stipends. The contract will be ratified at the beginning of May.

We are currently in negotiations with the Town of North Reading DPW, Town of Hingham DPW, City of Waltham DPW, City of Medford School Custodians, and City of Medford School Security Guards, Monitors, and Tech Specialists. We have also had proposal meetings and will be meeting for negotiations with the following bargaining units: Town of Watertown DPW, City of Medford DPW, City of Medford Inspectors, DPW Superintendents, and Recreation Department, City of Malden Department Heads (newly organized).

In the Liquor Industry, we had a proposal meeting for the Drivers and Helpers that work at MS Walker in Norwood. These essential employees have worked tirelessly through the pandemic making record profits for this Company. The contract expires on Halloween and we will make sure that the 73 Teamsters at MS Walker get what they deserve, one way or another!

In Organizing, we have been certified by the Massachusetts Department of Labor Relations as the certified bargaining agent for the following bargaining units: City of Medford Parking Department, City of Medford Department Heads and Assistant Department Heads. We have had proposal meetings with both groups and look forward to negotiating strong first agreements for them. We also have a petition pending to represent the City of Medford School Directors, Administrators, and Assistant Principals.

At UPS, we have settled the MRA paid time-off case that was deadlocked at the NEAPGC panel and filed to the National Panel. The settlement resulted in full back pay for several hundred members in the Chelmsford facility. We have also disbanded the Safety Committees in all buildings as they are only for show as the Company could care less about the safety and well-being of Teamster members. OSHA has visited the Chelmsford facility several times in the last few months and has called the Company out on unsafe working conditions. Let your stewards know of any safety concerns in your facility.

As a reminder, file an injury report with your manager and steward anytime you are injured at work, regardless of how severe or mild the injury. If the manager does not allow you to fill out a report, we have created a Teamsters injury report that the stewards can provide to you. Also, if management delays providing you with medical treatment for an injury at work, have your steward call an ambulance and contact OSHA.

### Vice President/Business Agent Joan C. Corey

I would like to send a heartfelt thank you to all our Brothers and Sisters for your demanding work, courageous efforts, and continued support and loyalty day in and day out.

The employees at Work, Community, Independence, Inc., a non-profit organization, ratified their first Teamster Local 25 contract with 98% voting Ves. Lam proud to represent these 200+ Teamsters

voting Yes. I am proud to represent these 200+ Teamsters who provide critical in-home, and employment/day support to adults with a wide range of intellectual disabilities, including physical, sensory, autism and acquired brain injury, helping them to achieve a rich, meaningful life within the community. Thank You to Steward's Elmane Louijeune and Earnest Huggins for your dedication to your co-workers, profession, and union.

Town of Concord Highway and Grounds Members unanimously ratified a three-year agreement. Meal breaks are now incorporated into the paid work schedule. The negotiating team is now paid for time spent for contract negotiations. There are annual wage increases with annual performance increases. Reimbursements for all fees, and continuous educational units to hold licenses. Employer pays costs for DOT Certificate, Pesticide License and Arborist Certification each year. We added the Juneteenth holiday and improvements to vacation language, and now three days granted immediately upon hire. There are clothing, gear, and equipment increases. As always, Thank You to all the united members of this unit, Steward Tish Hopkins, Negotiating Team member's Rich Hathaway, Tim Jones, and Joe Garozzo.

Town of Concord E-911 Public Safety Dispatchers ratified a three-year agreement to include annual wage

increases with annual performance increases and a Lead Dispatcher wage adjustment to commensurate with added responsibilities. Shift differential increases, now have positive impacts on all shifts. Special assignment payments all increased and are included in base rates. There is a new EMT stipend and the addition of the Juneteenth holiday. A special Thank You and words of encouragement to all our First Responders in Concord Dispatch Center who are holding that department together during this challenging time.

Tewksbury School Nurses unanimously ratified a successor three-year agreement. The first year of the contract includes a re-do of the existing step structure, with significant increases applied within the steps. All increases frontloaded retroactive in year one, then three years of compounded wage increases. Lead Nurse annual stipend increased. We added a new National Board Certification stipend of \$2,000 annually with increases to professional development credits and compensation and improvements to bereavement days. Thank You to Steward Deb Kraytenberg and Negotiating Team Kelly Constantino and Angie Reaney, who provided extensive documentation and data, which was key to achieving the great gains in this agreement.

Negotiations continue with the City of Woburn Department Heads and Professional Staff, Town of Acton, Town of Sudbury, Town of Brookline, Next Step Healthcare, Tewksbury School Administrators, and the City of Boston Property Management Engineers.

Upcoming proposal meetings and negotiations are beginning with our members at City of Chelsea DPW, Everett Hospital, Cambridge Health Alliance Respiratory Therapists, SSRECC Dispatchers, SSRECC Supervisors, Greater Lawrence Sanitary District, Somerville Housing Police and Winthrop Clerical.

At Air Canada, arbitration was filed at the national level regarding the company attempting to implement cross utilization of our members in different classifications. All local appeals moved to the national level and pending in-person meetings at Logan Airport.

Gate Gourmet workers kicked off the National Days of Action March 15-21. Our members in Boston joined hundreds of Gate Gourmet Airline Catering workers in eleven kitchens across the country to participate in the job action. Airlines have received billions of dollars in pandemic bailouts. It is time that essential airline catering workers get their fair share in wages and receive affordable healthcare. Stay tuned as we continue this fight across the nation.

Boston was successful getting all members that had been out of work for Covid related absences, and all members not paid for any holiday abutting a Covid absence, made whole in every way, and our members have now received all back pay dating back 12 months. In closing, I am honored to serve the members of Local 25, and now the opportunity to serve members across this nation. I will never forget that it is the members who put me here, and it is the members whom I will serve. Thank You and God Bless America!



### Business Agent Jason A. Lopes

I hope everyone and their families are having a great start to 2022. Congratulations to General President O'Brien on his victory in the IBT election, and congratulations to new Local 25 President Tom Mari on his new appoint-

ments as the Principal Officer of both Local 25 and Joint Council 10 in New England. 2022 is going to be an exciting year, both here at home and nationally for the Teamsters. I would like to take a personal point of privilege and thank General President O'Brien for appointing me as the lead negotiator for the National Red Cross contract on behalf of 25 Teamster locals, and for also appointing me to the position of Eastern Region Division Representative for the Public Services Division (a position I was formerly appointed to in the Health Care Division). I accept these appointments with great pride and promise to not let the membership down.

It was a busy winter on the negotiating front. We successfully negotiated new three-year agreements with the City of Cambridge Public Works Supervisors and the Emergency Communications Supervisors. The contracts provided substantial economic gains, and secured Essential Personnel Pay for our members who provided services throughout the pandemic, as well as many other improvements. We reached a new three-year agreement for UMass Boston Police Lieutenants; this agreement included substantial financial gains, provided for Essential Personnel Pay, and created a new step on the wage scale for Senior Employees to achieve. We also ratified a new five-year contract with Certainteed in Norwood. This agreement brought wage increases of 24% over the life of the agreement, as well as maintaining the Teamster health insurance and pension benefits. Currently we have a three-year tentative agreement with the American Red Cross for both the local and national contracts, narrowly avoiding a nationwide strike on the eve of expiration, and securing our members' Teamsters health care. Surveys will be going out shortly for the VPNE parking negotiations, which will commence at the end of the summer.

We currently have four cases filed for arbitration. One case is for the S&S Fleet Mechanics regarding vacation scheduling. Another case is scheduled against Apple Studios in regard to

vacation payouts in the Movie Division on the production "Chili." The other two cases are with the American Red Cross over the elimination of sick time banks in violation of the MA State Paid Sick Time Law.

In Freetown, things are heading in the right direction at the warehouse. We were able to negotiate an increase to the starting wage to \$20.00 per hour, as well as get all current members a \$1.00 per hour increase. Since the enactment of the wage increase, we have had over 100 new hires, and have been able to drastically reduce the number of outside help in the building. We hope to have all third-party Selectors out of the facility by the end of the Summer. We continue to need Selectors and Fleet Mechanics at S&S, so if you know anyone that is interested, please reach out to me via email or phone. Also, please keep an eye on our website for job opportunities across the Local, as it is updated regularly.

In the Movie Division, it is gearing up to be a busy Spring and Summer. We currently have six productions up and running, with many more scheduled for a Summer/Fall start up. The addition of the Marina Bay and Foxboro movie production facilities (along with New England Studios in Devens), will hopefully keep Teamsters working year-round in this industry.

I would like to Thank the Essential Workers at Local 25, who did a great job keeping the streets safe and clean throughout the Winter, especially the City of Cambridge, who I have the pleasure of representing. Also, a special shoutout to those delivering goods (Costa Fruit, Stop & Shop, Manfi Leasing, QCD), protecting our streets (UMass Lowell PD, UMass Boston Lieutenants) and providing life-saving medical services (American Red Cross, Cambridge E911). You continue to show why Teamsters do it best.

It was great to see everyone in person again at the Autism Gala in January, and then the true unsung heroes of Local 25, our Stewards, at our in-person Steward Seminar in April. I also hope to see everyone out on the course, chasing my horribly hit drives at the Annual Scholarship Golf Tournament.

### Business Agent Andrew P. Walsh

Brothers and Sisters, I hope you and your families are well. The efforts made throughout this lingering pandemic by our members who continue to deliver goods and services shows the power of the Teamsters Union. Without your

hard work, the country stops, and I Thank You for keeping our community supplied with the essential needs that keep us safe.

In the Solid Waste Division, we were able to negotiate a new four-year agreement with Republic Services Dispatcher Group. This is the group's second agreement under Local 25. As we have reported in the past, this is a tough company to deal with, and we were successful in getting this group into the New England Teamsters Pension Fund, 100% free medical company funded, added holidays and cleaned up language to protect our members. I want to Thank this group for standing together against this company.

In the Airline Division, United Airlines bargaining has begun. This contract expires in December, which has roughly 10,000 members that work under this agreement. This is the only CBA that I represent under the Railway Labor Act, which dictates how we bargain with the company. I will report back on the progress of the talks.

Since my last report, I have received new assignments, which includes Aggregate Industries Redi Mix and Paving Division, Boston Sand and Gravel, Cannistraro, Cox Engineering, Blouin Sheet Metal, Flush, W.L. French, MON Landscaping, Alton Equipment, Structure Dereck, New England Foundation, L&H Equipment, Interra Concrete and JF White Construction.

We have sent out surveys and held a proposal meeting in order to begin negotiations for the Massachusetts Heavy Highway Agreement. The proposals are being finalized, and we will be reaching out for dates to get these negotiations underway. This agreement sets the prevailing wage for our Construction Division members.

Other negotiations we are getting prepared for include: P. Gioioso & Gioioso Bros. Equipment, Ryerson Steel, Milton Cat, Independent Pipe and Boston Pipe. As you can see, this is a very busy time of year, and I look forward to working with all the members and negotiating committees to get the

best contracts for our members.

I am currently working with Field Representative Peter Alvarado on the sale of Angelica. This has been a long process, and the original buyer FDR Services has backed out, and a new company – Century Linen from New York – is now trying to purchase the company locations in Somerville and Worcester. I hope to report back soon on a successful sale to keep our members working, and our hospitals stocked with clean linens.

In closing, it is an honor and privilege to work with President Mari and represent the greatest Teamster members, and the greatest Teamsters Local in America.



### Business Agent Joseph F. Foti

Since my last report, we have completed negotiations with AEI DHL Freight Forwarding and the members overwhelmingly ratified the National and Local 25 Supplemental Agreement. The three-year agreement includes increases in wages

and pension, new half-hour paid lunch language, additional paid option days, and MLK paid holiday. I would like to thank Business Agent John Murphy for his assistance in the negotiations.

My new assignments include OB Hill, Shaughnessy & Ahern, WH Glancy, Admiral Metals, Marr Rigging, Marr Aerial Platform, and Marr Scaffolding.

At Marr Scaffolding we negotiated a new five-year agreement in March that includes increases in wages, pension, and health and welfare contributions for maintenance of benefits, two additional sick days, and new double-time pay for all holiday and weekend work. The contract was ratified unanimously. Thank you to Steward Bill Badmington for his assistance during negotiations. Surveys have gone out for members at Admiral Metals and a proposal meeting will be held soon for their contract negotiations.

At DHL, I have been privileged with an appointment to



the National Negotiation Committee. These negotiations at the National and Local supplement have been long and difficult, but with the backing of our members, I have no doubt that we will secure the contract our hard-working members deserve. We also continue to docket many cases to grievance panels, most recently for ongoing penalties for pay shortages. We plan to hear these cases soon.

At UPS our members, after being forced to work long hours during Covid and the long holiday season, are now being rewarded by the company with contract violations of the layoff language in our supplement. UPS also removed the market rate adjustment that was being paid to part-time employees above the contractual rate of pay for more than a year. This rate was taken from our part-timers after the company boasted of record profits during the holidays, and with little notice to the members. After Local 25 filed a complaint with the Attorney General's office, all UPS part-time employees in Massachusetts received a retro pay adjustment. The settlement cost the company over \$450,000.00.

I would like to congratulate President Tom Mari, Secretary- Treasurer Steve South, Vice President Joan Corey, and new Field Representatives Brian Hatch and Nancy Campbell on their new positions. Thank you to all the stewards who attended the Stewards seminar held at the Union Hall. It was the best turnout I have ever seen. Thanks to all who came to and supported the Autism Gala. It was great to see everyone again.



### Business Agent Michael C. Halley

I would like to start my report by thanking you, the members, once again for your charity and generosity this past Christmas in making the 2021 Local 25 Toy Drive an immense success. Together with the hard work and dedication of

Co-Chair Joe Conti, Billy Grubbs, Bobby McAllister, Ann Marie Kelly and Katie MacDonald, and countless volunteers, we were able to collect just under \$174,000 in cash and toys to help spread Christmas cheer to hundreds of Teamsters Local 25 families in need. I continue to be so honored to be part of something as special as this Toy Drive. Thank You again for showing your Teamsters Pride and making me proud to be a Local 25 Teamster.

Congratulations to President Tom Mari, Secretary-Treasurer Steve South, and Vice President Joan Corey on your new leadership positions, as well as newly appointed Field Representative's Brian Hatch and Nancy Campbell. I am proud to be on such a great team and look forward to

fighting alongside all of you for our members.

Since my last report, we have been working hard to successfully negotiate strong Teamster contracts for our members. For our members working as Custodians for the Norwell School System, we were able to negotiate a new three-year agreement, with increases in holidays, sick leave buy-back, attendance bonuses, longevity bonuses, boot and equipment allowances, as well as the highest wage increases we have achieved there in the last three contracts. I would like to thank that group for being such a strong group of proud Teamsters, as well as Joe Healey and Bob Thayer, who served on the bargaining committee. Special thanks to Joe Healey, a friend, the biggest Red Sox fan in New England, and longtime Steward there, who retired shortly after negotiations. He will be replaced by Bob Thayer. Joe, you will be missed, and Bob will undoubtedly do a great job as well.

At National Express, our members working as Dispatch Supervisors unanimously ratified a five-year agreement, with substantial front loaded wage increases, improved holiday schedule, an increase of four floating holidays, as well as a 50% increase in their Teamster pension. Special thanks to Steward Mo Johnson, who worked relentlessly at the bargaining table to win these improvements for the group, as well as National Express Super Steward Ricardo Acevado.

At St. Elizabeth's Hospital, another unanimous ratification for our hardworking Security Guards there. The five-year agreement includes corrections in wage/seniority inequity, with heavy front loaded wage increases, increases and improvements to differential pay and vacation. Steward Jay Owens was an unbelievable asset during negotiations and was integral in achieving this contract.

At Signature Flight Support, we had a unanimous ratification of a three-year agreement. \$3.00 per hour increases in the first year for Techs and Customer Service, and \$5.00-\$9.00 per hour increases first year for Mechanics. We shortened the vacation accrual language, allowing members to get additional vacation weeks faster, and increases in Lead pay, Training pay, Holidays, wage caps. They also got protections and improvements to attendance and sick leave language, and a Union HealthCare plan that our members there can enjoy, starting in 2023 when AllegiantCare will be available for them to choose, as well as a ratification bonus. Steward Dave Eaton did a great job at the bargaining table, as well as Igor Moura, and made this great agreement happen.

We have just ratified a five-year agreement at Cambridge Offset (Potters Printing), complete with annual wage increases of 5%, and 100% Medical and Teamster Pension maintained, while we are very close to also reaching tentative agreements at Transdev, Peter Pan and Hudson RPM.

We were able to come to agreement with Horizon Air Service to make a market rate adjustment to our existing collective bargaining agreement there, where our hard-working drivers will see a \$1.50 per hour increase effective March 1, on top of their scheduled contractual increase this June. They will also get an addition \$1.00 per hour, on top of their scheduled contractual increase in 2023.

Since my last report, I am now honored to represent five new assignments - Arlington Coal and Lumber, ABC Supply, AirGas, Beacon Sales and Kraft Power. I am excited to represent these groups moving forward. We will be beginning negotiations for Beacon Sales in the coming weeks. We have upcoming negotiations at Lindenmyer Munroe, Eastern Bus, Paul Revere Logan Shuttle, Penske, as well as Theatre Contracts for the Wang, Shubert, Colonial and the Boston Opera House.



### Business Agent Peter (Pedro) Antonio Alvarado

I am extremely proud and honored to be part of the Local 25 team. I want to Congratulate President Tom Mari on taking over the greatest Local in the country. President Sean O'Brien set the bar extremely high

in this great Local, and I firmly believe that under President Mari's leadership, this team will raise the bar even higher.

At UPS, in the Feeder Division, we have many part-time members looking to become TCD. We will be monitoring the TTQ lists to ensure that the company is maintaining an adequate bench.

In the Package Division, the members at the South Boston building continue to vigorously enforce the contract. We are holding the company accountable for Supervisors performing bargaining unit work. I want to Thank my Stewards for all their hard work.

In the Somerville building, with the help of our shop Stewards, members are starting to come together, and are holding the company accountable. We continue to have many payroll issues with this company.

At Hertz, we are currently in negotiations on a contract that expires on June 7. We also have three outstanding arbitrations against this company. We have many issues that need to be addressed, and we plan on fixing them.

In the Laundry Division, Angelica is currently in talks to be sold. We are monitoring this situation, and will ensure that with any sale, our members will be protected, and our contract honored.

At Aramark, we had a successful proposal meeting on March 27. This contract expires on July 8. We will be starting negotiations next month, and plan on negotiating a strong agreement for these members.

At Crown Linen, this contract agreement is set to expire May 22. We have negotiations scheduled for this month. We plan on getting the best contract possible for this group.

At East Boston Neighborhood Health Center, we will be meeting with the company in July to address wages in their annual wage reopener. We lost member Ricardo Guevara unexpectedly and ask the membership to keep his family in their prayers.

At Northeast Electric, this contract expires later this year. We will be getting to work to set up proposal meetings over the next few months.

At Cummins, we were successful in negotiating a great contract for these members in March.

In closing, I want to Thank the great members of Local 25 for their support. I will continue to fight day in and day out to protect our members' rights.



### *Field Representative* **John A. Murphy**

The DiSilva Transportation contract has been ratified, with wage, health and welfare and pension increases. I am waiting for dates to negotiate the Waltham Lumber and Supply contract, then the Stewards and I will get some dates to negotiate.

Massport members ratified their contract on April 16. We represent 400 members in this group. Great job by Chief Steward Spike O'Brien.

At DHL National Negotiations we are close to a MOA, and have given the company another Extension Agreement, to finish up all outstanding supplements around the country.

In the Freight Division, I met with YRCW to review some changes of operations they are proposing in the Western Region between YRC, Holland and Reddaway. The New Penn Clerical Unit are now Teamsters with increases in wages, as well as Teamster health and welfare and pension.

At Manfi Leasing/Stop & Shop we have sign off on a Market Rate Adjustment in pay of \$0.75 to coincide with the April pay raise of \$0.65, for a total of \$1.40 April 3. This is certainly not enough of an increase for the work our members do, but the Manfi Leasing contract is a third-party contract to Stop & Shop, and it's not up until March 29, 2025. I will be working to fix some other issues with sub-contractors and forced overtime. As well as preparing to put on a discharge case at the NEJA Committee.

The IBT won an arbitration award with T-Force, where the company laid-off (Red Circle) Road Drivers there by breaking their guarantee. The back pay is more than \$1.5 million, with more than \$21,000 going to four Local 25 Drivers, with two members receiving \$10,204.33. T-Force is now part of the Freight Division.



### *Field Representative* **Brian J. Hatch**

I would like to take this opportunity to introduce myself to the membership. I have been a proud Teamster since 2007. In this time, I have worked in the Movie and Theatrical Division, Moving and Storage Division, and for the last

eight years in the Oil Division at Global.

I am humbled to have an opportunity to represent the members of the greatest Local in the country. I would like to congratulate President Mari on his new position of President/Principal Officer of Local 25, and Secretary-Treasurer/ Principal Executive Officer of Teamsters Joint Council 10 New England.

I am currently representing the Oil Division, which consists of 19 contracts, including newly organized Dunlap Energy. Some other assignments I have are City of Everett DPW, Clerical and 911 Dispatchers, as well as the newly formed City of Malden Department Heads.

These companies were put on notice. Local 25 would not settle for anything less than an industry leading contract. This contract was overwhelmingly approved by 98% at the ballot.

In closing, it is an exciting time to be in organized labor, and an even better time to be a Teamster. President Mari and General President O'Brien are putting employers on notice. The days of concessionary contracts are in the past.

The Organizing Department met with President Mari in his first week after taking over Local 25. It was clear in our meeting that President Mari has an aggressive vision for organizing and is completely committed to growing our Local. In our

meeting we discussed short-term goals, long-term goals, our strategy, and the resources needed to achieve those goals.

We will continue to organize as we always do, but with an emphasis on member involvement and organizing in our own workplaces, talking to non-union workers on the road, or assisting with established campaigns. Our priority is to build an army of educated members, because that is where our strength is - in the membership. The Organizing Department is developing a curriculum for Volunteer Organizing Training, where members can come to their Union Hall and begin to learn how to have a conversation with non-union workers to identify issues, debunk anti-union rhetoric, important laws about organizing and how to get contact information for a Local 25 organizer to follow up with. This will give the Local more eyes and ears in many more workplaces, which will bring in even more opportunities to organize.

Internal organizing is crucial for our growth. We will be creating a template for Business Agents and members to identify targets within the places we currently represent that will help us with outreach. Public Sector Organizing has been identified as a "hot" target for Local 25 right now. We are fielding many calls and having some success in organizing in this arena, so for the foreseeable future we will focus quite a bit on the Public Sector.

With the explosion of the cannabis industry, we will be looking for opportunities to organize. This includes in stores, from seed to sale and delivery.

Our Amazon Organizing Team has been hard at work every day, building an army of organizers through identification, education, and field work. # Teamsters Local 25 takes message directly to voters at annual Hingham Town Meeting

Our Hingham DPW workers have been without a contract since June 30, 2021. On May 1, more than 70 Teamsters lined the entrance to the annual meeting, distributed flyers and spoke to residents about the work these essential workers have been doing every day to keep the town clean and safe. Remembering Those We Have Lost on Workers' Memorial Day

n April 28, we gathered to pay our respects to Teamsters who have lost their lives on the job and recognize the impact these tragic losses have on their families and co-workers. This annual event marks the anniversary of the Occupational Safety and Health Act (OSHA) that ensures every worker the right to a safe job. Teamsters and the labor movement fought for and won this law for all workers.

The ceremony this year was a stark reminder of the fragility of life as we honored the lives of two Teamsters Local 25 Movie Division brothers we lost way too soon. Paul Woodward, age 67, died of Covid-19 on April 18, 2021, and was a 40-year-Teamster. Michael Gagnon, age 49, died suddenly

while working on set September 22, 2021, and was a 23-year-Teamster.

The retiree chapter led a solemn closing ceremony that included the reading of all of the names on the Memorial stone by Vice President Bill Grubbs as Trustee Herb Andrews rang the bell to signify that they are now home. Trustee Kevin Lally lowered the flag as a lone bagpiper played Amazing Grace. Chapter President Joe Conti closed the ceremony.

Teamsters Autism Gala breaks fundraising records

Successful in-person event the very first of its size held at the Boston Convention Center in two years

umber 13 was anything but unlucky for the annual Teamsters Local 25 Autism Gala held on January 8th. After a two-year hiatus due to Covid-19, the 13th annual Gala returned to the Boston Convention Center as the venue's first large-scale event since the pandemic shutdown. More than 800 guests descended on the convention center and opened their hearts – and wallets – to make the gala a huge success.

"This gala was our most successful yet and it's all because of our generous sponsors and members," said Local 25 President and Autism Gala Co-chair Thomas G. Mari. "Our autism fund is about helping people with autism learn, work and lead fulfilling lives. Whether you were a sponsor, purchased a ticket or bid on a raffle, you helped fund these worthwhile charities and we are beyond grateful."

Because of the generosity of our sponsors, Teamsters Local 25 was able to provide more than \$320,000 to our partner organizations during the pandemic, so there was no lapse in funding during that difficult time. Following this year's gala, \$350,000 was awarded to 11 autism organizations, all of which work tirelessly to improve the quality of life for people and families living with autism.

Emcee Hank Morse introduced then-Teamsters Local 25 President Sean M. O'Brien as a longtime advocate to those living with autism. O'Brien, who founded the gala back in 2007, spoke passionately about how the Local 25 Autism Fund has evolved, starting by focusing on research and advocacy, then community events such as Challenger Baseball Leagues, and ultimately persuading Beacon Hill lawmakers to pass ARICA (An Act Relative to Insurance Coverage for Autism), ensuring those with autism have access to health insurance coverage. O'Brien capped his speech by noting with pride that the Local 25 Autism Fund has come full circle by now focusing on helping adults with autism live fulfilling lives with housing and good jobs with health and welfare and a pension.

"The work that we have done and all we have accomplished during the past 15 years wouldn't be possible without all of you," said Teamsters General President O'Brien. "I am nothing but grateful for the opportunity to lead Teamsters Local 25 and this charity. This charity will go on and we will never say no to a family in need."

The 2022 Essential Puzzle Piece Award was presented to the William E. Russell School for its tireless commitment to children with autism and developmental delays.

The 2022 Boston Harley motorcycle raffle was won by UPS worker Elvis Kuka. Thank you to everyone who participated in the raffle!

"General President O'Brien made the Teamsters Local 25 Autism Fund a priority and that will not change," said Mari. "We will continue the great work that he began and look forward to helping those who have been impacted by autism."

Organizations that benefited from the successful gala were extremely grateful for the support. "The Medford Invitational Tournament (MIT) family is so proud of the partnership we formed with the Teamsters many years ago," said MIT President Ron Giovini. "This grant opens the door of opportunity for our organization and energizes us to continue to provide for the needs of our community with a focus on autism. Thank you to General President Sean O'Brien, President Tom Mari, and the entire Teamsters organization for always having our back." # TeamstersCare COVID-19 At-Home Test coverage through Express Scripts

# **Teamsters Local 25 Driver Training Program Expands CDL Program** *State announces \$975,000 in funding that will be matched by training fund*

eamsters Local 25 is playing a large role in helping the state address the supply chain and truck driver shortage. On April 8 State Senator Paul Feeney joined area legislators and Local 25 officers, agents and CDL students and alumni to announce \$975,000 in state funding to expand the Teamsters Local 25 Driver Training Program.

"Teamsters Local 25 operates the best truck driver training program in the country and we are proud to be an important part of the solution to address the supply chain and worker shortage issues," said President Thomas G. Mari. "Thank you to Senator Feeney for securing badly needed funds to expand the program which will enhance our ability to train the next generation of drivers and get more people into great union jobs as commercial truck drivers."

The Teamsters Local 25 Training Fund will match the funds 1:1. Since 2016, nearly 400 students have attended the Local 25 CDL school, with 42% identifying as female and/ or non-white. The program has a "first try" passage rate of more than 90 percent, nearly double the national average. Employment opportunities created by the Local 25 Driver Training Program typically result in starting wages from \$20 to \$37 per hour, with significant long-term earning potential well beyond that.

"I am thrilled to present this money to address this critical aspect of the supply chain emergency," said Senator Feeney. "This expansion of the Teamster 25 Driver Training Program will continue to support training to students for long-term


careers as well-qualified and safe Commercial Drivers. This training program is a direct and proven pipeline to good paying, benefits providing, important middle-class jobs, all while addressing the continued depletion of the truck driving industry. This investment in the Driver Training Program will address the severe shortage of commercial drivers throughout the Commonwealth and Nation while creating good paying, blue collar, union represented jobs, to support hundreds of Massachusetts families and businesses."




### Retiree News


union leaders of all time. Great things are in store for our international union with him at the helm.




