Dear Student of Teamsters Local Union No. 25 Member:

Please find the Scholarship Application form for the 2024 Teamsters Local Union No. 25 Memorial Scholarship Award.

The Scholarship Awards are in the amount of \$2,000.00 each and are non-renewable. The application will be available only to High School Seniors graduating in May or June of 2024. The winners will be contacted in early May and the awards will be presented at the Local 25 Membership meeting on Sunday, May 19, 2024.

Please NOTE that the deadline for returning the completed application is FRIDAY, MARCH 8, 2024. The original application must be sent to Teamsters Local Union No. 25, attn: Scholarship Department, 544 Main Street, Boston, MA 02129.

Along with the application form, the applicants must return their college entrance examination board test results, high school transcript and an essay (topic of your choice). Selection of the Teamsters Local Union No. 25 Memorial Scholarship Award winners will be made by a review board of impartial educators from the community and will be based on academic records and the required essay of 250 - 300 words.

Applications will be accepted from the dependent children of Local 25 members in good standing, and from children of retired or deceased members, provided that the surviving spouse has not remarried. Dependents of International and subordinate organizations, Officers and Agents, are NOT ELIGIBLE to apply. Also, ineligible are the dependents of members on withdrawal, but who have not retired. Good standing is defined as a member who has fully paid his or her initiation fee, monthly dues, assessments, and any outstanding fines prior to the issuing of the application.
